• **Grader Blade Purchase:** Aaron received three (3) informal bids for a truckload of blades. A truckload is approximately 300 pieces. Most are at least six (6) weeks to three (3) months out.

- **Micro-Surfacing Projects:** 517<sup>th</sup> possibly oil. The State is doing approximately 44 miles of micro surfacing by Valentine, NE. It is roughly \$60,000.00 a mile. Utilizing state aid, Brian McDonald suggested trying to piggy back off of that project, since they will be 'in the area.' This may be three (3) years in the making. Knox County is in agreement to establish projects they agree to list projects in the area. Micro surfacing of approximately 10 miles of road, (roughly \$550,000.00). Aaron will work on listing projects. If Antelope County has shovels in the dirt and boots on the ground it will show they are proactive in getting projects complete. JEO will be contacted to evaluate cross sections.
  - **Ashfall Road** cannot wait the three (3) years for the County.
- Orchard-Summerland Road: Aaron suggested adding shoulders in the area of Summerland School where the road is very narrow. The Commissioners discussed multiple roads throughout the County that are narrow, i.e., road north of Tilden and Orchard going south. Aaron stated eight-mile road, north of Tilden sluff, Orchard Road are our main projects.
- Packer Purchase: Steel Drum Aaron stated the County is going to be doing more projects for themselves. From shoulder projects, patching and other road fixes. Aaron presented he did not think he would be asking for additional equipment until this 'equipment bid' fell into his lap. Discussion of equipment and purchase. The packer is a 39-inch roller, and could be used in small projects and bigger projects. They vendor (Murphy Tractor) is selling two (2) 2016 Packers, both have partial warranties. The first packer has 54 hours on it and is retailing for \$32,000.00 the second has 236 hours retailing for \$30,000.00. Long discussion of pros/cons and current equipment fleet. Motion by Commission Krebs seconded by Commissioner Jacob to purchase the Packer with 54 hours at \$32,000.00, with funding from the current Road and Bridge Equipment Fund. Voting aye: Jacob, Smith, Krebs and Henery. Pedersen absent. Nays none. Motion carried. Sourcewell has bid.
