The Antelope County Board of Commissioners convened in regular session on Tuesday, April 12<sup>th</sup>, 2022 at 8:00 AM in the County Commissioner's Room, Antelope County Courthouse Annex, Neligh, Nebraska. Meeting was called to order by Board Chairman Charlie Henery with the following board members in attendance: Jacob, Smith, Krebs, Pedersen and Henery. Chairman stated that the open meeting laws are posted on the east wall of the Commissioner's Meeting Room with more copies available at the County Clerk's Office.

Notice of the meeting was given in advance thereof by publication in the three (3) county newspapers, legal newspapers printed and in general circulation in Antelope County, Nebraska as shown by proof of publication filed in the County Clerk's office. Agenda for said meeting was sent to all members of the County Board of Commissioners. Meeting was also available by ZOOM.

Pledge of Allegiance was recited.

**Improvement Grant: Neligh Young Men's Club** has submitted a request to update fireworks firing module for the 4<sup>th</sup> of July display. The request is for \$1,750.00. This request was approved by Antelope County Visitors Committee. Motion by Commissioner Pedersen, seconded by Commissioner Jacob to approve the request for \$1,750.00, from Neligh Young Men's Club. **Promotional Grant: Young N Lively Club (Elgin):** has submitted a request for promotional funds to help promote "Treasurer's In the Park". **Pledge Collateral** is at \$1,525,000.00, and \$250,000.00 FDIC insured.

Antelope County Visitor Committee: Rick Schuchardt met with the Commissioners. He gave a shout out to the members. And reviewed the grants and funding trends from the inception of the program to now. He presented facts and graphs of the trends. The Improvement Fund is lower on funding simply on the fact that the grant request is larger in nature. No further action/discussion.

AFLAC Chelsea Riha, AFLAC regional manager met with the Commissioners because it had been a number of years since the AFLAC representative met with the Commissioners. Chelsea stated AFLAC would like to have participation at 30%-50%, currently Antelope County is at approximately 14%. AFLAC would like to be the only choice for employees' supplemental benefits. She stated the choice adds confusion to the employees. She stated AFLAC also has a policy that is available to employees that they will review claims of greater than \$400.00 to make sure the proper payment was made at no cost to employee. This benefit is because Antelope County participates with AFLAC. Chelsea Riha shared if the County were to continue the association with other carriers, they would probably close their county connection. Current enrollees, would go to bank draft, and no additional policies would be purchased through payroll deduction. The decision to participate will be made in May.

Jimmy Powell, from **Carbon Summit Solutions** met with the Commissioners regarding the proposed pipeline to transfer CO2 off of the fermentation process at the ethanol plants to be placed in the ground in North Dakota. The project encompasses five states, Iowa, Nebraska, South Dakota, North Dakota and Minnesota. The timeline: federal and state permits in 2022, construction in 2023, with operation beginning late 2<sup>nd</sup> Quarter to mid-3<sup>rd</sup> Quarter 2024. Discussion of land owner easements, in conjunction with land, environment and cultural surveys – all being 100% of the pipeline route. Discussion of property and personal taxes. County Assessor, Kelly Mueller stated this would be centrally assessed. The audience participated in discussion today. Multiple questions asked regarding pipeline and future actions. The pipe and coating were discussed in depth. Decommissioning, farming or condition of land after pipeline is set. There are guidelines to avoid most inhabited dwellings. They are planning to have shunts in place to help with leaks and flow issue detection. Mr. Powell reiterated the intention to keep all local officials informed. As they talk with landowners, they will shape the pipeline route. There intention is to work with the environment and landowners. Mr. Powell stated the intent is to reimburse the landowner at fair market value. During build they are requesting a 100 feet easement, after construction they will continue with a 50 feet permanent easement. Seth Harder, CEO with Husker Ag, spoke in favor of the project and reiterated the probability of utilization of the pipeline to held with future issues. Currently, Husker Ag employees approximately 60 jobs, which in today's economy cannot be held loosely. Without the progress of the project the ethanol plants may become stagnant. He stated right now his sister plant in Iowa is using the CO2 for multiple ways, but is planning to utilize the plan to send to North Dakota in the future.

**Zoning Administrator Report**: Megan met with the Commissioners. Presented an administrative plat.

- Megan presented an Administrative Plat for James and Marla Schindler. Nash Schindler (son) is purchasing seven (7) acres from his parents who own the parent parcel. This is a split from parent parcel. The Administrative Plat for 7.0 acres is being presented today. This parcel lies in the SE½SE¼ of Section 35, Township 25, Range 7 West of the 6th PM, Antelope County, Nebraska. This is an old homesite, access is in place and setbacks meet current guidelines. Motion by Commissioner Smith, seconded by Commissioner Jacob to approve the Administrative Plat for 7.00 Acres. Voting aye: Jacob, Smith, Krebs, Pedersen and Henery. Nays none. Motion carried
