AND ANTELOPE COUNTY LIBRARY ASSOCIATION

THIS AGREEMENT IS MADE AND ENTERED INTO BY AND BETWEEN Antelope County, Nebraska, a Political Subdivision, by and through its Antelope County Board of Commissioners, (hereinafter referred to as "County") and the Antelope County Library Association consisting of the public libraries of the Cities of Neligh, Elgin and Tilden, and the Villages of Orchard, Clearwater, and Oakdale, each being Municipal Corporations, by their respective Mayors, Chairpersons, and Trustees, respectively.

WHEREAS, Nebraska Revised Statute Section 13-801 Et. Seq., R.R.S. 1943 (reissued 1997), the "Nebraska Interlocal Cooperation Act" authorizes the parties hereto to unite their efforts and resources to accomplish the intent of this agreement; and

WHEREAS, the Antelope County Library Association, by and through their respective community libraries does agree to provide all services and materials to the residents of Antelope County, Nebraska, whom are not residents of the respective Municipal Corporations, under the same terms and conditions as provided to the residents of such Municipal

WHEREAS, the Antelope County Library Association's mission statement is to serve the communities of Neligh, Elgin, Tilden, Orchard, Clearwater and Oakdale as well as all residents of rural Antelope County. Nebraska, as a resource for information, entertainment, cultural opportunity, and educational development, thereby enhancing and enriching the lives of the users. That the libraries within said communities shall be active and progressive institutions providing materials that reflect the needs and interests of its patrons. That said Library Association shall seek equitable funding, share materials and solutions to problems, provide access to resources beyond each of their individual facilities by cooperative agreements with library organizations at the local, regional and state levels and to strive to make use of all possible resources and ideas to meet the needs of the patrons of each of the communities and of the residents of the entire county.

WHEREAS, Nebraska Revised Statute Section 77-3442 R.R.S. 1943 (reissued 1996) provides that \$.05 per \$100.00 of taxable valuation of property subject to the county levy may only be levied to provide financing for the county's share of revenue required under an agreement executed pursuant to the Interlocal Cooperation Act. NOW THEREFORE, in consideration of the foregoing recitals and their mutual covenants here and after expressed, the parties agree as follows:

Each of the communities: Orchard, Clearwater, Neligh, Flgin, Oakdale and Tilden by and through their public libraries commonly referred to as the Antelone County Library Association shall provide all services and materials currently available through the public libraries, to non-residents of their community so long as such residents are residents of the County, under the same terms and conditions as such services and materials are provided to the resident of their respective communities.

That the County agrees to contribute financially to the Antelope County Library Association and agrees to implement a levy not to exceed \$.05 per \$100.00 of taxable valuation of property on an annual basis to the Antelope County Library Association, by paying to the respective libraries of the Cities of Neligh, Elgin and Tilden, and the Villages of Orchard, Clearwater and Oakdale the applicable amount as provided by this agreement. That a like amount shall be included in the County's budget, reviewable, on an annual basis. This funding to be supplemental funding and not replace other funding.

That this agreement shall have an effective date of July 1, 2022, and shall continue in full force and effect for a period of one year.

This agreement shall not be construed as to form an additional political subdivision. The parties hereto agree to comply with any and all laws, rules and regulations, whether same be local, state or federal, required in the administration and execution of the terms and provisions of this agreement. Further, that no party will assign any rights granted under

This agreement shall be administered by the Antelope County Clerk, as directed by the respective board of the parties hereto.

IN WITNESS WHEREOF, the parties have executed the agreement on the dates appearing directly below their signatures.

Road Superintendent Report:

- Access Permit: Motion by Commissioner Smith, seconded by Commissioner Jacob to approve access permit submitted by Ben Hochstetler to place an access permit along 511th Avenue in the NE½SE½. Access is for new home construction. Mr. Boggs stated he will be doing some ditch work but voiced no issues. Voting aye: Smith, Jacob, Krebs, Pedersen, and Henery. Nays none. Motion carried
- **Tree Issues:** Aaron stated he has a list of tree issues through out the County. He asked the Commissioners how they wanted to handle it. They suggested he write a letter and send a picture to each of the landowners giving them 30 days to respond.
- **Dust on Roads:** Merlin Bolling met with the Commissioners regarding heavy dust on the roads both north and south of Clearwater. During season of 2021 hard surface roads in the Clearwater area were ground and 'Sinclair' dirt was laid. This is a very heavy dirt and when it is stirred up sits in the air for longer times. The visibility goes down significantly and sometimes it is impossible to see. With the lack of water in 2022 the product on these roads has not been able to settle like other roads. The Road Superintendent will be heading to Husker Harvest Days to check out the Soybean road solutions being promoted. Hopefully, he will find answers there. Merlin wanted to go on record stating that is very dangerous situation and the roads are very unsafe. Additionally, Janice Bolling, Fred Thiele, Bruce Anderson and Leonard Kerkman were also in attendance.

Summit Carbon Solutions: Ben Fuller met with the Commissioners with a brief overview of the pipeline project process. He stated they are gathering voluntary participants along the proposed route. Summit Carbon Solutions is a subsidiary of Summit Ag in Iowa. They farm corn and soybeans. The pipeline will support corn and soybean growing. Construction start date is late Summer 2023. They have acquired 9.8 miles of right of way, of the 26.98 miles – for approximately 36%. Ben Fuller is a relationship manager. They will be boring under words at approximately eight (8) feet. Mr. Full voiced no issues with the North Dakota neighbors. This spring, Husker Ag had stated that this pipeline is important to their survival. Ben stated only outside investor is from South Korea. The pipeline is at a minimum of four (4) feet in the ground. CO2 is an asphyxiant and shutoffs will be no more than 20 miles between, with emergency shut offs at specific locations.

Follow up discussion regarding dust in Clearwater area. Commissioner Pedersen asked about the 'Sinclair dirt' used in the Prairie Breeze Projects. Is the Sinclair dirt used currently the same product - question of the dry conditions. Traffic may be up on the road compared to before the grinding. Discussion of limiting the speed limit and wondering if that would help. No action.

Vendor Claims: Discussion of documentation on Spud Trucking Claim. The claim was presented without load weight or documentation. Motion by Commissioner Krebs, seconded by Commissioner Smith to approve vendor claims except Spud Trucking Claim for \$375,760.00 Clain #22090208. Voting aye: Pedersen, Smith, Krebs and Henery. Nays none. Jacob abstains. Motion passed.

The levy will see an increase. Tax asking increase by \$1,000,000.00, the budget is showing \$1,600,000.00 worth of capital improvements, over the last month to six (6) weeks the numbers have been reviewed three (3) to four (4) times during meetings, including a couple of special meetings for that alone. Commissioners have cut budgets and worked with the figures and the Road & Bridge Superintendent has reported to be bare bones. The General offices have been adjusted as well. There really is nowhere to cut even after the concerns that could be voiced. Discussion of the post cards does offer confusion.


