The Antelope County Board of Supervisor's convened as a County Board of Equalization on Tuesday, February 11, 2014 at 10:00 AM in the County Supervisor's room, Antelope County Courthouse annex, Neligh, Nebraska. Meeting called to order by Chairman Schwager with the following board members responding to roll call: Bolling, Brandt, Kerkman, Baker, Williby, Henery and Schwager. Antelope County Assessor Heather McWhorter and Antelope County Treasurer Sandy Knapp were also present. Chairman Schwager stated that the open meeting laws are posted on the east wall of the Supervisor's room with more copies available at the County Clerk's office.

Notice of the meeting was given in advance thereof by publication in the four county newspapers, legal newspapers printed and in general circulation in Antelope County, Nebraska as shown by proof of publication filed in the County Clerk's office. Agenda for said meeting was sent to all members of the County Board of Supervisor's.

Motion by Brandt, seconded by Baker to approve the exemption application for tax exemption on real property submitted by Peace United Church of Christ for the property they purchased to be used for a parsonage; said legal description of the property is Lot 5, and the North 14' of Lot 6, Block 6, Creighton's First Addition, City of Tilden, Nebraska. Those voting aye: Bolling, Brandt, Kerkman, Baker, Williby, Henery and Schwager. Nays none. Motion carried.
