The Antelope County Board of Supervisor's convened in regular session on Tuesday, June 24, 2014 at 9:00 AM in the County Supervisor's room, Antelope County Courthouse annex, Neligh, Nebraska. Meeting called to order by Chairman Schwager with the following board members responding to roll call: Bolling, Brandt, Kerkman, Baker, Williby, Henery and Schwager. Chairman Schwager stated that the open meeting laws are posted on the east wall of the Supervisor's room with more copies available at the County Clerk's office.

Knife River has 4,000 to 5,000 tons of millings for sale at \$9.00 per ton. Motion by Henery, seconded by Williby to purchase the millings from Knife River at \$9.00 per ton and hire Klabenes Construction to haul them at \$150.00 per hour per truck. Motion by Kerkman, seconded by Brandt authorizing Chairman Schwager to sign the Subgrant between Nebraska Department of Health and Humans Services Division of Children and Family Services Child Support Enforcement and the Antelope County Clerk of the District Court. Motion by Henery, seconded by Williby authorizing the transfer of expenditures in the amount of \$1,463.68 from the County Treasurer expenditure account, \$257.92 from the County Zoning Administrators expenditure account and \$5,626.96 from the County Historical Society expenditure account to the miscellaneous expenditure account within the General Fund and to authorize the transfer of expenditures from the Road and Bridge District 1 expenditure account in the amount of \$11,042.45, District 6 expenditure account in the amount of \$36,094.41 and District 7 expenditure account in the amount of \$21,875.53 to the At Large expenditure account within the Road and Bridge fund. Representatives from Hammer Insurance, Anchor Insurance and NACO Benefits Services met with the county for the review of the county health insurance quotes. A committee of Supervisors Williby, Kerkman and Schwager was set to review the health insurance quotes and report back to the board on August 12, 2014. No formal motion made.
