The Antelope County Board of Commissioners convened in regular session on Tuesday, June 10th, 2025, at 8:00AM in the County Commissioner's Meeting Room, Antelope County Courthouse Annex, Neligh, Nebraska. The meeting was called to order by Board Chairman, Charles. with the following board members in attendance: Jacob, Dittrich, Krebs, Williby and Henery. 

Antelope County Visitor Committee: The Committee consisting of five (5) members is a committee responsible for reviewing and approving various requests from Antelope County entities requesting funds from the Promotional Funds and Improvement Funds. Three (3) members of the Committee are up for re-appointment for a four (4) year term. Rick Schuchardt, Lynell Stelling, and Stephanie Meuret are the members whose terms are expiring and are all willing to do another term. Motion by Commissioner Williby, seconded by Commissioner Jacob to approve the appointment for the three (3) board members for a four (4) year term. Voting aye: Jacob, Krebs, Dittrich, Williby, and Henery. Nays none. Motion carried.

Zoning Administrator Report: Mrs. Wingate met with the Commissioners. Presented an administrative plat.

• Administrative Plat: Rainbow Farms presents with an administrative plat in which the plan is to separate approximately 6.354 Acre tract from the parent parcel. This parcel is in the SE¼ of Section 15, Township 25, Range 6, West of the 6th PM, Antelope County, Nebraska. The administrative plat is for 6.354 acres and is intended to allow Mr. Rice to graze cattle. Mrs. Wingate states access was granted last fall; she voices no opposition and recommends approval. Motion by Commissioner Dittrich seconded by

Commissioner Jacob to approve administrative plat as presented. Voting aye: Williby, Dittrich, Krebs, Jacob and Henery. Nays none. Motion carried.



- Mrs. Wingate reports the public hearing for a Conditional Use Permit for a 354-foot Cellular Tower last Wednesday, passed unanimously. Two (2) members of the public were in attendance. The Commissioners will hold this public hearing on June 24th, 2025 at 9:30 AM.
- No further report or action.

Board of Equalization: 9:19 AM Motion by Commissioner Williby, seconded by Commissioner Jacob to open as a Board of Equalization. Voting aye: Jacob, Dittrich, Krebs, Williby and Henery. Nays none. Motion carried. Met for approximately one (1) minute. Motion by Commissioner Dittrich, seconded by Commissioner Jacob to close as a Board of Equalization and return to regular session. Voting aye: Jacob, Dittrich, Krebs, Williby and Henery. Nays none. Motion carried.

Reimbursement Grant Application: Antelope County Weed Department is eligible to get up to \$5,000.00 grant reimbursement to help control the spread of yellow flag iris along the river corridor. This grant reimbursement is sponsored through the State of Nebraska – Department of Agriculture. Mr. Cornett suggested this 'grant' used to be given by the State of Nebraska Department of Agriculture and the qualification has changed to a reimbursement status. The Commissioners agreed it was in the Counties' best interest for Mr. Cornett to pursue this reimbursement.

Dispatch Radio System: Sheriff Moore met with the Commissioners regarding the purchase of a new radio system for the dispatch call center. This has been on the Sheriff's radar for a couple of years. Today, he presents with bids from Mindshare and Zetron. They appear to be within a couple of thousand dollars of each other. The systems are comparable; however, it appears Zetron has removed various capabilities from the original bid package. After review and discussion, it was determined the Mindshare system although quoted at \$115,618.10 is actually \$106,618.10 compared to \$117,455.58 from Zetron. The Commissioners agreed the Mindshare System seems to be a very viable option. Sheriff Moore will continue to work with the representatives to finalize the best option advantages and maintenance agreements. The Commissioners agree to allow Sheriff Moore to proceed. The Sheriff will present at the next meeting. No further action today.

Road Superintendent Report:

- Oversize Permit: (198-199-200) JMS Crane and Rigging LLC out of Billings, Montana submitted three (3) oversize load permits to access Towers. The route is 523rd Avenue, 835th Road to Highway 14. Mr. Kluthe approved of the routes. The move was executed on Monday. No issues were reported. Motion by Commissioner Jacob, seconded by Commissioner Williby to approve permit. Voting aye: Dittrich, Jacob, Krebs, Williby and Henery. Nays none. Motion passed.
- Oversize Permit: (201-202) In and out. Crane Service Inc. submitted a permit to access Tower 29. Mr. Kluthe stated this permit was/is issued after the fact as the crane was witnessed moving without a permit. Mr. Kluthe reported to Invenergy. At this point they are authorizing the move out (and in-post). Mr. Kluthe suggested 846th Road west to 514th Avenue to Highway 70. No issues reported. Move has been executed. Mr. Kluthe reports they have been easy to work with. They stated they had the permits from the state, and 'forgot' about the County permits. Motion by Commissioner Dittrich, seconded by Commissioner Williby to approve permit. Voting aye: Dittrich, Jacob, Krebs, Williby and Henery. Nays none. Motion passed.
- **Application for Payment**: North Construction Construction manager for the Bridge removal project pay application was presented for payment of \$21,800.00. Motion by Commissioner Williby, seconded by Commissioner Jacob to approve and pay application. Voting aye: Dittrich, Jacob, Krebs, Williby and Henery. Nays none. Motion passed.
- **Brunswick Northwest** Bridge: Bids were opened last week. Numbers were verified and affirmed by the State of Nebraska Department of Transportation and Brian McDonald, Antelope County Highway Superintendent. Mr. McDonald made the recommendation to approve the bid submitted by Dixon Construction for \$619,230.88. Motion by Commissioner Jacob, seconded by Commissioner Williby to accept the Dixon Construction bid as verified. Voting aye: Dittrich, Jacob, Krebs, Williby and Henery. Nays none. Motion passed.
- Royal North Bridge: Bids were opened last week. Numbers were verified and affirmed by the State of Nebraska Department of Transportation and Brian McDonald, Antelope County Highway Superintendent. Mr. McDonald made the recommendation to approve the bid submitted by Midwest Infrastructure, Inc. for \$243,763.31. Discussion regarding start dates and bids within \$3,000.00. Motion by Commissioner Krebs, seconded by Commissioner Jacob to accept the Dixon Construction bid as verified. Voting aye: Dittrich, Jacob, Krebs, Williby and Henery. Nays none. Motion passed.
- **Micro-surfacing update**: Widening of 513th Avenue going well. There is a lot of down time because trucking material from Norfolk causes delays. Averaging about one (1) mile a day, seems like a lot of down time, despite Antelope County having trucks running and utilizing a couple of live bottom trailers.
