The current guidelines/agreement is dated approximately 1989. In 2022, Dr Charlie was appointed as the chairman of the department and has been strategically directing the department to 1) Strengthen Nebraska Agriculture and Food Systems; 2) Inspire Nebraskans & Their Communities; and 3) Enhance the Health and & wellbeing of all Nebraskans. 
