May 11th, 2021 Antelope County Board of Commissioners Neligh, Nebraska

The Antelope County Board of Commissioners convened in regular session on Tuesday, May 11th, 2021 at 8:00 AM in the County Commissioner's Meeting Room, Antelope County Courthouse Annex, Neligh, Nebraska. Meeting was called to order by Board Chairman Charlie Henery with the following board members in attendance: Jacob, Krebs. Smith, Pedersen, and Henery. Chairman stated that the open meeting laws are posted on the east wall of the Commissioner's Meeting Room with more copies available at the County Clerk's Office.

Notice of the meeting was given in advance thereof by publication in the three (3) county newspapers, legal newspapers printed and in general circulation in Antelope County, Nebraska as shown by proof of publication filed in the County Clerk's office. Agenda for said meeting was sent to all members of the County Board of Commissioners. Meeting was also available by ZOOM.

Pledge of Allegiance was recited.

Agenda: Motion by Commissioner Pedersen, seconded by Commissioner Jacob to approve agenda as presented. Voting aye: Jacob, Pedersen, Smith, Krebs and Henery. Nays none. Motion carried.

9:53 AM Tom Thiele, Antelope County Land Owner, met with the Commissioners regarding concerns on 516th Avenue. He attempted to get on the agenda and did not make the 24-hour advance notice. He stated it is very rough and has a number of holes. Discussion of maintenance issues, base under road, grinding, millings, and costs. Mr. Thiele understands the budget/cost and the fact there are many roads in the County, regarding long term plans and expectations. When the weather cooperates, Aaron is hoping to get some grinding on the 'bad' spots, and laying millings on same. Mr. Thiele asked about taking everything back to bare bones and starting over. It was discussed that a portion of this road is Village of Clearwater responsibility. Grinding roughly cost \$23K per mile. Discussion of overlay, etc. Aaron again mentioned the weather has to cooperate – meaning we need some warmth.

Insurance – Fiscal Year 2021-2022: Follow-up discussion regarding insurance coverage for the fiscal year 2021-2022. Because this is a major expense of the County, the issue needs to be researched in greater detail. Commissioner Krebs believes there are more affordable options out there however, it is more of a long-term research. She suggested research and make a decision, and then changes could be implemented later in the year. During the research Commissioner Krebs suggests a committee be formed including officials and employees. Because of timing issues regarding options, Commissioner Krebs, in order to honor and meet deadline imposed, made a motion to continue with the NACO Insurance Plan (utilizing the \$1,500.00 deductible), with a review of coverage options, carriers and other avenues for insurance coverage in the fall of 2021. Motion is seconded by Commissioner Pedersen. Voting aye: Jacob, Smith, Krebs, Pedersen and Henery. Nays none. Motion carried.

Zoning Administrator Report: Liz met via ZOOM today.

Motion by Commissioner Krebs, seconded by Commissioner Jacob to approve underground permit. Voting aye: Smith, Jacob, Pedersen, Krebs and Henery. Nays none. Motion passed.
- Oversize Loads: Callen Myers, from Rocky Mountain Crane Service submitted oversize permits. Aaron has worked with them and suggested a workable path, and voices no issues with recommendation to approve. Motion by Commissioner Jacob, seconded by Commissioner Pedersen to approve oversize permits. Voting aye: Smith, Jacob, Krebs, Pedersen, and Henery. Nays none. Motion carried.

- **850**th **east to County Line:** there is roughly \$501,000.00 from TransCanada money, that will be utilized on this. There is approximately \$300,000.00 surplus from these projects. Aaron discussed purchasing a grader. The Commissioners suggested this money be spent on roads. Commissioner Smith suggested hiring an employee.
- **Equipment Auction:** Special purchase from Auctions. Advertise for informal quotes, wave bidding requirements. If purchasing off the auction site, put bid back in the paper with five (5) days later you can purchase. NACO suggested appointing a purchasing agent to carry out auction purchase. This is a unique situation as new products are hard to locate. Discussion of money availability for purchase.
- **Tracking Device:** Aaron will be purchasing seven (7) more tracking devices through Razor. Three (3) dump trucks, spare semi, two (2) leased tractors. This should take the total count to 38. Discussion on sign pickup. It was agreed it would cover a safety standpoint.
- **Newman Signs:** Response letter went to Joe Abler, no action. Discussion of finding products at other vendors. Commissioners stated with the dispute, we will hold on payment.
