Clearwater Public School is hoping to sell the property, however, currently there is no access to the property as the access was sold to the Educational Service Unit when they purchased the school building. Mike and Marty wanted to know if the Commissioners could authorize an access to the property. Discussion today centered on the need to obtain a survey and possible a workable plan for access. Discussion of possible obtaining access through a neighboring parcel and authorization for ingress and egress along the west side of the 'county' property in the Clearwater Barn location. Motion by Commissioner Smith, seconded by Commissioner Jacob to withdraw motion. Hydraulic lift verses mechanical lift was a long discussion. It was decided not to make any action today, and to add to June 22nd meeting agenda. Dealer stated the bid is open until the trailer is sold. *******11:30 AM after Bid opening a bid from the Wrays LLC was received. Bid not opened as not timely.


Old Courthouse Structure Follow-up: Jerry Berggren, Architect, met with the Commissioners regarding the old courthouse structure. He was contacted a couple of months ago regarding moisture in various areas of the original Courthouse Structure. Mr. Berggren presented today with some estimates on replacing the roofing structures on the courthouse buildings, and an estimate of masonry. Discussion regarding replacing roof and the masonry work and in what order same should be done. Discussion of type of repair and order regarding tax credits and utilization for off setting cost of repairs. The repairs could be done in steps, and individually bid. However, in order to capitalize on the tax credits the roofing would have to be done before the restoration work. Tax credits on the courthouse annex could not occur unless the annex is listed as a registered historic place – which would have to be filed and accepted. Jerry said they believe there may be too much weight on the masonry bricks, so supporting the wall behind the veneer construction as they were constructed with soft bricks. In previous repairs, they built a steel plate to carry the weight out wider – hoping to prevent cracking on the first floor. That lends it to the fact they want to do the complete area, top to bottom at a time. Instead of the upper and then lower, previous repairs called for fixing second floor on all for corners/sides, then constructing the first floor. They believe there is a combination of things interfering with current bricks as are. The estimate presented is for the damage they are expecting, however there could be more damage. The interior repair was not in any estimates, and would be a separate estimate. The windows in the original structure are about 40 years old, and probably due for an update. Discussion regarding total repairs could be greater than \$2,000,000.00. Short discussion of fixing verses building. Mr. Berggren asked to enter into contract with Antelope County for the Architectural design, and his time. His cost is approximately 12% of the construction cost. Mr. Berggren will draw up a contract regarding same. The Commissioners requested to add item to the 22nd of June agenda, they also requested a courthouse walk through tour during same meeting.

NIRMA Billing Statement: Discussion regarding premium increase. Commissioner Smith feels this premium is extremely high, and other options need to be pursued. The Commissioners agreed other options could be explored. Commission Pedersen stated we would need to start a search now if we want to have something in place, equaling same quality-quantity. However, at this time the premium is due now. Motion by Commissioner Pedersen to pay NIRMA premium. (Claim #'s 21060070 & 21060161). Motion is seconded by Commissioner Jacob. Voting aye: Krebs, Jacob, Pedersen and Henery. Nays Smith. Motion passed.

Newman Signs- during the pervious couple of months, Aaron Boggs has been working with Newman Signs regarding items that were sent, not what the County 'thought' they ordered. It has been a discussion over the last couple of months. County Attorney has not reviewed or weighed in on the bill. Motion by Commissioner Smith, seconded by Commissioner Pedersen to hold discussion/action until County Attorney can review. Voting aye: Smith, Jacob, Krebs, Pedersen, and Henery. Nays none. Motion carried.

12:29 PM Commissioner Smith left meeting for approximately 5 minutes.

Interlocal Agreement – Knox County Line Bridge (Ashfalls North): Knox County presented signed interlocal agreement to share cost of repairs to bridge. Motion by Commissioner Pedersen, seconded by Commissioner Krebs to approve and adopt resolution as presented. Voting aye: Smith, Jacob, Krebs, Pedersen, and Henery. Nays none. Motion carried.



Zoning Administrator Report: Liz was not available today. No report.

Function transfer: Commissioners requested we wait until the 22nd of June Meeting and review all of the transfers.

Commissioner Smith rejoins meeting.

Zoning Administrator Position: Commissioner Pedersen stated our applicant has accepted the position, and is wanting to work two (2) days a week. Motion by Commissioner Pedersen, seconded by Commissioner Jacob to appoint Riley Applegate as Zoning Administrator, working two (2) days a week at \$20.00. Voting aye: Smith, Jacob, Krebs, Pedersen, and Henery. Nays none. Motion carried.

Road Superintendent Report:

- Underground Permit: Nancy Bitney presented an underground permit. Road Superintendent has not had an opportunity to look at. No action today.
- Access Permit: Chris Gale presented an access permit for 856th Road in the NW¼ 15-26-5, West of the 6th P.M., Antelope County Nebraska. Aaron voiced no opposition or concerns. Motion by Commissioner Smith, seconded by Commissioner Jacob to approve access permit. Voting aye: Smith, Jacob, Pedersen, Krebs and Henery. Nays none. Motion passed.
- Oversize Loads: Jared Puetz, from Borsheim Crane Service submitted three (3) oversize permits. Aaron has worked with them and suggested a workable path, and voices no issues with recommendation to approve. Motion by Commissioner Pedersen, seconded by Commissioner Jacob to approve oversize permits. Voting aye: Smith, Jacob, Krebs, Pedersen, and Henery. Nays none. Motion carried.
- Wheel Packer: Rose Equipment are supplying parts for oil pump. The have a wheel packer for rent for \$7,500.00. Discussion. Commissioners stated they did not think for current projects this would be financially fit. Rose Equipment did tell Road Superintendent if we transported the packer ourselves, they would not charge us to use, as a test drive.
- **Armor Coat:** Aaron has requested Sta-Bilt to return to Antelope County to complete some armor coat projects in September. They have not returned Aarons call. Aaron is wondering if we can contact another vendor to complete the work.
- **Road Ditches:** Pierce County has a program in which they hire two (2) people to mow ditches. They have two (2) \$15,000.00 disc mowers, rent two (2) lawn tractors for the season. Aaron feels this is feasible. They mow all ditches twice a year. Pierce County feels this has been very beneficial. No action.

Safety Barriers: Bids for the safety barriers in the courthouse were submitted. Discussion. Motion by Commissioner Smith, seconded by Commissioner Jacob to hire and authorize Aaron Kinnan to install safety barriers. Kinnan bid is \$9,250.00 (low bid) for the safety glass in the Assessor, Treasurer and Clerks Office, and place safety barriers for Zoning Office and Clerk of the District Court Office when plans are decided to construct same. Voting aye: Smith, Jacob, Krebs, Pedersen, and Henery. Nays none. Motion carried.

Budget: Commissioner Krebs commented we will have to continue to work on the budget. Officials have budgets as of the end of May. Due to recent changes the budget hearing has to be held separate in an open meeting with no time limit. Public hearing could be held in August, allowing time to make hearing requests if necessary. No formal action.

Discussion on mechanical detach trailer. The Commissioners did not seem to be supportive of same – when-if- an hydraulic lift is available.

Discussion on cemented Pierce-Neligh Road – on Pierce County side. Still looking good. Discussion regarding future cement/overlay projects.

Commissioners requested protest hearings be set on the 13th day of July after lunch.

No other issues to discuss.

Adjourn: Motion was made by Commission Pedersen, seconded by Commissioner Jacob to **adjourn**. Voting aye: Smith, Jacob, Pedersen, Krebs and Henery. Nays none. Motion passed.
