Improvement Grant: Neligh Park Foundation; Request for \$2,500.00 was submitted for an inclusion playground equipment. The Antelope County Visitor's Committee denied the request, although mentioning how awesome the playground idea was. The Commissioners mimicked the greatness of the project. Discussion. Motion by Commissioner Dittrich, seconded by Commissioner Williby to deny the request on the recommendation of the Antelope County Visitors Committee. Voting aye: Williby, Dittrich and Henery. Nays none. Krebs and Jacob were absent. Motion carried.

838th Road Culvert: Jerry and Jan Heithoff met with the Commissioners regarding a culvert that is backing up onto his property located in Section 4, Township 23, Range 6 West of the 6th P.M. Antelope County, Nebraska. During the recent downpouring of rain he had approximately 17.05 acres of flooding damage. This includes approximately 1½ feet of corn stalks in and around the flood pooling. Discussion of this culvert. In 2021, Antelope County replaced a culvert about a half mile down the creek from this culvert. At the time Kokes Construction LLC received the bid, which was for placing two (2) culverts at about \$134,000.00. Mr. and Mrs. Heithoff were looking for ideas on how to remedy this. They intended no ill intent and wanted to make sure this was taken care of going forward. Road Superintendent, Aaron Boggs, states this project is on the One and Six Road Plan, but has not been estimated at this time. To start the ball rolling, the Commissioners stated they believe the Highway Superintendent, Brian McDonald should do a cost estimate and engineering study for future improvements. County Attorney Joe Smith weighed in that he did not see necessary negligence, as this was not foreseeable damage. Thus, the County is NOT on the hook for this. After the study and quote is submitted, the Commissioner's will devise a plan to improve the situation after the engineering study. The Commissioners promised a good faith effort in getting the culvert to drain properly. Mr. Heithoff was instructed that he could track his expenses related to this, and if necessary, could submit an insurance claim; however, nobody believed it would be a covered insurance claim but left the option open. The Road Superintendent will contact Highway Superintendent to conduct study and engineer proposals. No further action today.

Radio Replacement – Law Enforcement Center: Sheriff originally estimation for upgrading radio was low. He requested the item be tabled, as the expense was more than planned, and it is not in the budget.




Zoning Administrator Report:
