The Antelope County Board of Commissioners convened in regular session on Tuesday, June 12, 2018 at 8:30 AM in the County Commissioner's Room, Antelope County Courthouse Annex, Neligh, Nebraska. Meeting was called to order by Chairman Kerkman, with the following board members responding to roll call: Schindler, Jacob, Schwager, and Kerkman. Henery absent. Chairman Kerkman stated that the open meeting laws are posted on the east wall of the Commissioner's room with more copies available at the County Clerk's Office.

There are two (2) more intersection 849<sup>th</sup> Road & 529<sup>th</sup> Avenue and 852<sup>nd</sup> Road and 529<sup>th</sup> Avenue, that are not highlighted that Invenergy will need to widen the intersection because currently the trucks will be scraping.
