## **Zoning Administrator Report:**

- Public notice regarding annexation in the Village of Petersburg.
- There is a planning commission meeting on the  $6^{th}$  of July at 1:00 PM. They will be discussing two (2) conditional use permits.

**Zoning Administrator Position**: Riley Applegate was offered and declined the position. In the interim the position was again open to the Courthouse employees. Jenn Kester, the only applicant, is currently working in the Clerk's Office has agreed to accept the position at \$18.00 an hour, but does not want to lose her position in the clerk's office. The discussion/agreement was to keep the employee in the Clerk's Office and when necessary, work in (and through) the Zoning Office. The recommendation is to utilize/pay the salary through Zoning for two (2) days a week and pay from the clerk's office the remainder of the time. Discussion of increasing the pay for Jennifer across the board. Clerk requested to increase Jennifer's pay to \$18.00 an hour full time. Motion by Commissioner Pedersen, seconded by Commissioner Jacob to appoint Jennifer Kester to Zoning Administrator as of June 21<sup>st</sup>, 2021. Increasing her wage to \$18.00 as hour, with 2/5<sup>th</sup> of her wage to be paid out of the Zoning Administration budget, the remainder out of the Clerk's budget. Voting aye: Smith, Krebs, Jacob, Pedersen and Henery. Nays none. Motion carried. Discussion regarding retaining Liz's pay for assisting and/or training of Jennifer Kester. Liz will present on the 6<sup>th</sup> of July.

## **Road Superintendent Report:**

- Access Permit: Ben Sayers submitted an access permit for 515<sup>th</sup> Avenue in the NW¼ 12-27-8, West of the 6<sup>th</sup> P.M., Antelope County Nebraska. Aaron voiced no opposition. Motion by Commissioner Smith, seconded by Commissioner Pedersen to approve access permit. Voting aye: Smith, Jacob, Pedersen, Krebs and Henery. Nays none. Motion passed.
- Underground Permit: Nancy Bitney submitted an underground permit for 523<sup>rd</sup> Avenue in the NW¼ of 29-26-6. This is a temporary underground permit. Road Superintendent requested to treat this as a permanent request, placing at 48 inches below surface, pipe used will be left after use. Mrs. Bitney thought the County would complete project. Aaron has explained the County normally does not handle this work. Motion by Commissioner Smith, seconded by Commissioner Pedersen to approve underground permit running 48" below road surface and owner must leave pipe when temporary use is complete. Voting aye: Smith, Jacob, Pedersen, Krebs and Henery. Nays none. Motion carried.
- **Underground Permit**: Garet Schindler submitted an underground permit for 510<sup>th</sup> Avenue in the NE¼ of 4-24-7. This permit is for electricity for irrigation well. Garet Schindler is owner, Boyd's Electrical Inc, is contractor. Motion by Commissioner Smith, seconded by Commissioner Jacob to approve underground permit running 48" below road surface. Voting aye: Smith, Jacob, Krebs and Henery. Pedersen abstains. Nays none. Motion carried.
- Oversize Loads: Jared Puetz, from Borsheim Crane Service submitted three (3) oversize permits. These are permits for out routes from the location approved last meeting. Aaron has suggested a workable path, and voices no issues with recommendation to approve. Motion by Commissioner Jacob, seconded by Commissioner Pedersen to approve oversize permits. Voting aye: Smith, Jacob, Krebs, Pedersen, and Henery. Nays none. Motion carried.
- Low Boy Trailer: RDO Truck Center brought the mechanical trailer to the Norfolk Truck Center, Superintendent Boggs, and Road Employees Allen Miller and Ray Schlecht tested the trailer. The mechanical adjustment is a difficult task and is not something the Road Superintendent is interested in. Discussion of options and various actions. In follow-up of bid opening from the 8<sup>th</sup> of June, a motion was made by Commissioner Smith to not accept the RDO bid presented. Motion is seconded by Commissioner Jacob. Voting aye: Smith, Jacob, Pedersen, Krebs and Henery. Nays none. Motion carried. Discussion continues regarding purchase of hydraulic lifts from vendors. There is limit product availability. The Wray's, LLC a dealership out of Sawyer, Kansas has a lowboy detachable trailer on their lot. A couple of Commissioners, and road employees have contacted the Wray's, LLC regarding trailers on their lot. Superintendent Boggs asked them if the Commissioners make a motion today to commit to purchase if they would hold the trailer. They are willing to work with us. Motion by Commissioner Krebs, seconded by Commissioner Pedersen to commit to purchase a 2022 Witco 52 Ton Challenger lowboy detachable trailer from the Wray's, LLC for \$46,500.00, Voting aye: Smith, Jacob, Pedersen, Krebs and Henery. Nays none. Motion carried.
- TC Laydown Yard: TransCanada is working on an exit plan. TransCanada has not asked to be released from the Road Use Agreement. Aaron is trying to contact someone to see if they are interested in 'selling' the product that may be left at the laydown yard. He is not familiar with product still on the lot, and will continue to see if the County can capitalize on purchasing product, dirt or millings, as opposed to hauling all of that product out.
- Clearwater Lagoon: Clearwater is planning a lagoon south of town. They will be trucking 44,000 yards (2200 loads). They are hauling from Thiele Dairy area to the site. This is a public roadway, as long as they have legal truck loads this is not a problem. The use of the road is public access. Concerns of speed and access were discussed. They may need a temporary access off of the road. Village of Clearwater, or the contractor will be filing an access permit.
- Striping Roads: Aaron has been talking to Brian McDonald and Tim Baxter regarding striping on of the hard surface roads in the area of Summerland School. Aaron believes striping can be done as to whatever the Board chooses. ADT traffic count decides whether a white strip has to be painted if there is a center line. A guestimate of cost would be approximately \$1,000.00 a mile.

**Budget:** Motion by Commissioner Pedersen, seconded by Commissioner Krebs to allow the Clerk to make function transfers as needed to balance 2020-2021 budget. Voting aye: Smith, Jacob, Pedersen, Krebs and Henery. Nays none. Motion carried. **Juneteenth:** On Thursday, June 17<sup>th</sup>, 2021 the Administration declared a holiday observing Freedom Day on June 19<sup>th</sup>, being observed on June 18<sup>th</sup> this year – there was not ample time to coordinate closing courthouse etc. With a motion being made in January to observe any declared State and Federal Holidays questions about observing same. Discussion with other counties a suggestion was made for observing the holiday as a floating holiday in 2021. Discussion of how, when and where. It was discussed to add a 60-day limit for employees to 'use' the floating holiday and discussion of department busy times. Motion by Commission Pedersen, seconded by Commissioner Krebs to allow a onetime floating holiday for full time employees, to be used at the employee's discretion, depending on department heads approval before December 31<sup>st</sup>, 2021. Voting aye: Smith, Jacob, Pedersen, Krebs and Henery. Nays none. Motion carried.

11:31 Courthouse Tour by Commissioners: Antelope County Commissioners toured the courthouse complex, discussing various maintenance and grounds issues. No action.

12:16 PM: Commissioners met back in meeting room.

Roofing of Courthouse: Discussion of actions to replace the roofs on the courthouse complex, and other maintenance issues. Discussion of hiring an architect, action needed and how to figure out how to proceed and what fix should be first. Commissioner's state they believe the first action should be the courthouse annex roof. Motion by Commissioner Krebs, seconded by Commissioner Smith to advertise for bids for correcting, updating, fixing draining issues and reroofing of Antelope County Courthouse Annex, including the stair wings and associated drainage issues. Voting aye: Smith, Jacob, Pedersen, Krebs and Henery. Nays none. Motion carried.

No other issues to discuss.

**Adjourn**: Motion was made by Commission Pedersen, seconded by Commissioner Jacob to **adjourn**. Voting aye: Smith, Jacob, Pedersen, Krebs and Henery. Nays none. Motion passed.
