The Antelope County Board of Commissioners convened in regular end of fiscal year session on Tuesday, June 25th, 2024, at 9:00 AM in the County Commissioner's Meeting Room, Antelope County Courthouse Annex, Neligh, Nebraska. The meeting was called to order Board Chairperson, Charlie Henery with the following board members in attendance: Williby, Henery and Jacob. Commissioner Dittrich was in hallway with County Attorney, Joe Smith. Commissioner Krebs was absent. Chairman stated that the open meeting laws are posted on the east wall of the Commissioner's Meeting Room with more copies available at the County Clerk's Office.

Team Alert Security System: Antelope County Clerk presented the commissioners with a quote for a security alarm system for the Courthouse through Applied Connective Technology. The contract and prices were shared via an email last week. The Courthouse had the Alertus system, which is the same principal however, it is outdated and is no longer operational. The quote of \$9,480.00 is the purchase and installation of the system. There will be a monthly maintenance fee going forward. The Department of Health and Human Services had inquired about a safety system and wondered what the County had in place. Discussion. She was hoping to get direction and curing for some of these issues. The Commissioners agreed we have a very competitive benefits package. All agreed an updated personnel manual would be helpful, as some if not ALL these issues could be addressed in the Employee Manual. It was decided to make the employee handbook a priority.
