The Antelope County Board of Commissioners convened in regular session on Tuesday, June 26th, 2018 at 9:01 AM in the County Commissioner's Room, Antelope County Courthouse Annex, Neligh, Nebraska. Mr. Schindler has contacted Don Zegers Construction to help erect the structure. Motion by Commissioner Schindler, seconded by Commissioner Schwager to proceed with sign construction. The funding for this project shall be expensed out of the building fund. Voting aye: Schindler, Schwager, Jacob, Henery and Kerkman. Nays none. Motion carried.

Board of Commissioner Meeting Minutes: Motion by Commissioner Schindler, seconded by Commissioner Jacob to approve the minutes of June 12th, 2018 meeting with the inclusion of the paid claim list. (The list was omitted during submission and reviewed before meeting today.) Voting aye: Schindler, Jacob, Schwager, Henery and Kerkman. Nays none. Motion carried.

Improvement Grant: City of Elgin requested grant money for shade structure outside of pool in their park. This was approved by the Visitor Committee on the 13th of June, 2018. And sent to the commissioners for approval. Motion by Commissioner Henery, seconded by Commissioner Schwager to approve funds for the City of Elgin Shade Structure per their request. Voting aye: Schwager, Schindler, Jacob, Henery and Kerkman. Nays none. Motion carried.

Budget was reviewed. After claim and payroll from the beginning of June was processed it was determined the Road and Bridge Fund had three (3) functions that had gone over budget. County Clerk Lisa and Road Boss Casey Dittrich reviewed these districts and determined the discrepancy was payroll and the functions the payroll was drawn from. During hiring over the last year, employees were paid through the functions that the employees who they replaced. As payroll administrators they were not informed of various plans to pay the employees at large, as Casey intended them to be paid out of District 8 budget. However, erroneously the payroll was run through the separate barns. It was determined these funds should be transferred and run through the At Lage (District 8). A journal entry was complete and all is currently balanced. Casey Dittrich reiterated the Road and Bridge Budget looks good as far as miscellaneous expenses and spending. He feels confident about the overall Road and Bridge budget. County Clerk expressed the rest of the budget is in fine shape. There are a very few claims that might have come in the mail today. Most all claims were processed for claim run today. The clerk is holding no claims to be processed through next year's budget. No action taken. There is a claim in the mix today to transfer \$600,000.00 from the General Fund to the Inheritance to repay some of the dollars used when cash on hand was sparse during the fiscal year. This claim is/was part of the claim process.

Road Repair South of Brunswick-Asphalt Overlay Repair: [193] Commissioner Schwager again discussed the problems of grinding the two (2) miles north of 854th Road on 527th Avenue. This has been the discussion during multiple board meetings. The plan was to grind these miles and return this area to gravel road using the milling obtained to mix with hot mix on the Copenhagen Road. During the past year the Commissioners have agreed that five (5) to ten (10) miles of asphalt needs to be grinded a year. Commissioner Schwager stated the ground was to soft and the gravel will not be beneficial to traffic. Gravel is getting hard to find. The Copenhagen Road is in huge disrepair at this time, it could be closed. The plan is to grind the two (2) miles and use the millings on Copenhagen Road. The two (2) miles can and will be graveled. To grind one mile without the other, will not be beneficial to traffic. The Commissioners agreed the grinding of the two (2) miles on 527th Avenue north of 854th Road and using the millings on Copenhagen. No further discussion/action.

Township Claims: Motion by Commissioner Schindler, seconded by Commissioner Jacob to approve payment of Township Claims. No discussion. Voting aye: Schindler, Jacob, Schwager, Henery and Kerkman. Nays none. Motion carried. Mitties Gravel: Sherman Township \$170.02 & Bazile Township \$207.57.

Permit to Move Structures x 2: Two (2) applications for moving transformers along county roads were submitted by Al DeKruif of VanDyke Company were submitted. They are a subcontractor for the wind farm. The plan is to move the 400,000pound gross load transformers from Brunswick (863rd Road) to 852nd Road. Section 2 in Township 27, Range 6 to Section 31, Township 26, Range 5. They will be using 15 axles with eight (8) tires on them each. It is overweight and oversized; the impact to the road should be minimum. They are steel axis. It will come to Brunswick by rail. Road Boss Dittrich did not see any issues with the permit. Constituent Dean Smith asked about the route and if the county road can take the impact. Mr. Smith asked about taking the transformer north of Brunswick to Highway 20 and around to head south on Highway 14. The plan is to move this transformer in July. The plan of the board is to have Road Boss Casey Dittrich talk to the contractor moving the structure to see if they are willing (and able) to change the route. We will wait on this decision until more information is gathered. During the Road Boss Report this permit was discussed. Dean Smith had contacted the Village of Brunswick, and they are in agreement they would rather see it go north out of Brunswick. Marlin Conry, Invenergy Road Superintendent did not see any issues, as the highway permits had not been applied for or issued yet. Commissioner Schwager made a motion to approve the moving of the Transformer going north of Brunswick. Motion seconded by Commissioner Jacob. Discussion about the denial by the state, but the commissioners did not think it would be a problem. Road Boss Dittrich said he would change the map on the permit, before it is approved. Voting aye: Schwager, Jacob, Schindler, Henery and Kerkman. Nays none. Motion carried.

Met as a BOE 9:33 to 9:37 AM. Motion by Commissioner Henery, seconded by Commissioner Schindler to meet as a board of Equalization. Voting aye Henery, Schindler, Schwager, Jacob and Kerkman. Nays none. Motion carried. Met for approximately four (4) minutes. Motion by Commissioner Schwager, seconded by Commissioner Schindler to go out of Board of Equalization and back to regular session. Voting aye Henery, Schindler, Schwager, Jacob and Kerkman. Nays none. Motion carried.

Liz Doerr, **Zoning Administrato**r presented an **Administrative Plat**/Lot Split. The plat is at the request of Jeremy Borer. It is a 5.26 Acre tract in the NE½NE½ 4-23-7. Building split, there is driveway access. Parcel is west of ELgin This is a clear-cut parcel. There were no objections voiced. Motion by Commissioner Schwager, seconded by Commissioner Jacob to approve plat. Voting aye: Schwager, Jacob, Schindler, Henery and Kerkman. Nays none. Motion carried.

Moving of Structure: Moving of transformer approved. (See above.)

Underground Permit: Motion by Commissioner Henery, seconded by Commissioner Jacob to approve the application for permit submitted by Charles Meis to place a permanent electric line beneath 515th Avenue south of 843rd Road in the NE¼ of Section 23, Township 24, Range 8 West of the 6th P.M., Antelope County, Nebraska. HMP Farms – owner, Jake Schindler tenant. Electric line to be used for electric wire to bin site. Conditions of burying line five (5) feet below road surface, must sign distance of line with red warning poles and maintain those poles, and plow down center of road. All work to be done according to County and State specs. Those voting aye: Schwager, Schindler, Jacob, Henery and Kerkman Nays none. Motion carried. **SimpleCulverts Program** – GIS Yearly Contract. Elgin Barn: Discussion of improving the Elgin Barn. Discussion with the contractor about adding on to the current structure, or construction of a new stand-alone structure. With the current condition of the current barn. The contractor believes it to be costlier, and a shorter life expectancy by tying it in. Casey discussed with him. The current discussion is of a stand-alone 50 x 74 feet shed, 2 x 6-inch studs on 24-inch centers with a walk through, and four (4) 12 x 14 feet overhead doors and openers. Four-foot centers on the trusses, four-foot stem wall, and 10 feet on top of that. (14-foot height). No floor in shed. \$54,115.00 (it would cost approximately \$17,000.00 concrete.)

This had been discussed at budget time last year. We would work with the city regarding drainage issues that are there now. It was asked if there would be a better location to build. Motion by Commissioner Jacob to proceed with the leg and paperwork on the project as presented. Motion seconded by Commissioner Schindler. Voting aye: Jacob, Schindler, Schwager, Henery and Kerkman. Nays none. Motion carried.

Gravel Shed: Discussion on a hoop building. Beckman Lumber does not construct hoop buildings but said he would give a deal on a steal shed. Mr. Beckman quoted a 24 x 36 - foot building, 12inch steel walls on top of a 4-foot stem walls. Three-sided shed. It would be 16 feet inside. Discussion of the height. Shed and labor only was quoted at \$8,825.00. Concrete for stem wall would be \$5,700.00. We would need a floor on that, quoted at \$4,000.00. Total at \$18,525.00. Various options were discussed. It was voiced this is a necessary to keep the gravel clean and dry. Road Boss Dittrich will look into a hoop building cost, and various wall options. No action.

During the May 8th Meeting discussion of merits, delivery dates, specs, and options. Payment options were discussed. The item was tabled to further explore financial options and budget allocations. Four (4) Antelope County Banks submitted competitive bids and payment options. Discussion of Road and Bridge Budget, which is satisfactory for purchasing at this point. The above maintainer bids were discussed and reviewed. The commissioners discussed resale value, longevity and useful life of the county's current inventory.

Motion by Commissioner Schindler, seconded by Commissioner Henery to purchase a NMC – 6-Wheel Drive Caterpillar and to purchase a wing with parts credit, for \$302,500.00. Making a down-payment today of \$70,000.00 today, \$70,000.00 in September and two (2) or three (3) annual payments in 2019 and 2020, financed through the Bank of Elgin. The bid for the CAT was \$302,500.00 includes a \$23,000.00 parts credit which will pay for the \$17,000.00 wing and leave approximately \$6,000.00 parts credit. Antelope County currently owns two (2) CAT maintainers (Neligh and Brunswick), and we have six (6) John Deere. CAT, John Deere and Kamutsu all had a representative on hand. Discussion of resale comparing current value on used machine as evidenced by Big Iron sale of items. Voting aye: Schindler, Schwager, Henery, Jacob and Kerkman. Nays none. Motion carried.

519TH Road Damage: During construction of the Upstream Wind Farm there has been multiple reports of the 'Wind Farm Traffic' on roads in rural Antelope County not on the Road Agreement. This has been happening repeatedly. On June 12th, shortly after the Commissioner Meeting, Marlin Conry reported to Casey there was a crane crossing on 519th Avenue (Royal Road) about two (2) miles north of Highway 275. He said there was some damage, and he was aware of it, and they were going to fix it. It is not on the Road Use Agreement. The RUA starts about two (2) miles south of there, running approximately ½ mile by James and Kathy Koenig. Casey did not go look at the area until after the crane had crossed and damaged the road. It was passable, but rough. At which time it was signed. On Wednesday, Casey drove out there and, on the way, he met an operator in a 966 M Payloader with a six (6) to seven (7) yard bucket full of clay (close to 20,000 pound). The operator was not on ride control, bouncing down the shoulder and about ran him off the road. Marlin was called right away. Casey drove a little way, turned around and met the same driver coming back empty. Both times Casey felt the exchanges were dangerous. Casey was upset/irate. He spoke with Marlin, they could noticeably see the marks and gages in the road. The foreman from IEA were called and the action was stopped. There was several (10-12) trips where they bounced down the road. For the crossing of the Top-Out Crane, which is over 1,000,000 pounds. On Tuesday, June 12th, 2018 the crane was supposed to cross the road. Seven hours later, the crane sat on the driving surface of the road for approximately two (2) hours. IEA had 18 inches of dirt down, they had 12'x12' crane mats. At 8:00 PM the cranes tail end left the road. At 10:30 PM, Marlin called and reported the damage to the road left the road impassable, and he was closing the road. They got the counties rolling barricades and closed the road. The next day, the laser transit showed compaction marks 52 feet apart, 5 feet wide, and compacted the road 8 to 10 inches. We filled the tracts with cold mix asphalt, we laid steel plates 5 x 10 feet and laid four-inch overlay on top of it. We posted 25 MPH sign with barrels around it. It is a fairly smooth temporary fix. Traffic has been fairly fast and frequent on that road. Invenergy is responsible for that damage, it is outside the road use agreement. We do not have documentation of the condition of the road before the damage was done. We have documented fresh and old damage, we can document the shoulder breakup from the loader bouncing. The road use agreement avoided Antelope County's asphalt roads for this reason. Invenergy has a history of repairing roads to better than previous. After compiling evidence, preparing a history, and talking with Marlin, he has agreed to repair this damage. Thinking this was an isolated incidence Casey believed this was a done deal. Casey asked for the boards direction on what should happen on this two (2) mile stretch. The commissioners agreed this is a subcontractor's problem. Understanding these two (2) miles need to be fixed. This road is a well-traveled road all the time. Patching of this road is not going to last over the long term. The two (2) miles have continually been used by Invenergy, although it is not on the 'road agreement' the road should belong to the road agreement. The 'Road Agreement' was part of the Conditional Use Permit. The Conditional Use Permit is in violation if they are utilizing roads not on the use agreement. Zoning Administrator says she can file a violation letter with a date to have it fixed by. She will start the violation process today. Invenergy created the roads they were going to use, it was not Antelope County input. There have been amendments to the road use agreement. Invenergy has agreed to 'fix' areas pointed out that are on the road use agreement. It was suggested to Marlin Conry to 'talk' to Invenergy and come back to the board with a 'fixit' plan. No motion was made to allow time for Marlin to get a plan in place.

849th Road & 529th Avenue Intersection: East of Neligh - This intersection comes to a peak. 529th Avenue is on the Invenergy Road Use Agreement 849th Road is not. Asphalt road is flat topped. Invenergy is unable to get their components through it. In order to make it passable it will take taking the grade of the intersection down five (5) feet. In order to complete this they will be altering 1200-1500 feet of 849th Road – asphalt. Casey will be videoing this intersection before construction. Invenergy will start lowering the grade on the 5th of July for approximately one week. They will grind the asphalt temporarily. The plan will be to asphalt it when the project is complete. Signage of the area is in question. There will be a detour marked. The Commissioners agreed this needs to be amended into the road use agreement. It will be on the agenda for July 3, 2018.

Hot Mix-Holt County: Casey has talked to a couple of Commissioners regarding Holt County hot mix protocol. Currently, Holt County uses all of the Nameplate Capacity Tax the county collects and keeps towards the hot mix repairs. Casey contacted the road superintendent in Holt County and they are willing to work with Antelope County in setting up a hot mix plan so both counties can utilize it and hopefully a cost savings if they can set up a single work yard. The commissioners asked for it to be on the agenda.

Motion was made by Commissioner Jacob seconded by Commissioner Schwager to **adjourn**. Voting aye: Schindler, Jacob, Henery, Schwager, and Kerkman. Nays none. Motion passed.
