9:15 Public Hearing: Commissioner/Chairman Henery opened the public hearing to close an approximate one (1) mile of 842<sup>nd</sup> Road between 531<sup>st</sup> and 532<sup>nd</sup> Avenue. (Between Sections 22-27, Township 24, Range 5) A petition circulated by Terry Larson gathered approximately 20 signatures. Road study completed by Highway Superintendent, Brian McDonald's recommendation is to close and the right of way and return it to the adjacent landowners – returning the entire road to the north property at the curve. Mrs. Larson was in attendance today. She states the road is NOT travelable by vehicle, you would have to have a utility vehicle; and the road tends to draw a drinking crowd leaving cans and trash in and around the mile and bridge. Mr. McDonald states he does not believe the road is passable and probably has not been in quite a while. And the study recommendation was to close the road. Discussion. 9:18AM Commissioner Henery asks for people opposed to testify. Calls three (3) times. No response. 9:20 AM Commissioner Henery calls for testimony in favor of the road closure. Mrs. Larson acknowledges the desire to close the road. Commissioner Henery calls twice more for testimony in favor. Further discussion amongst the Commissioners. Commissioners asks for clarification from Highway Superintendent on issues. There is a bridge in the middle of this road, which if closed the ownership will be transferred to adjacent landowner. A call was made to that landowner to make sure they were aware of the transfer, and if transferred the County would no longer be responsible for maintenance of the road and/or bridge. The landowner acknowledges and agrees with same. 9:23 AM motion by Commissioner Williby, seconded by Commissioner Dittrich to close public hearing. Voting aye: Jacob, Williby, Dittrich and Henery. Nays none. Krebs absent. Motion carried. Brian McDonald discusses further regarding closing of road, signage, and when it should be done. The Commissioners agreed to close the road. Discussion of traffic on the road – is accessed by ATV to check cattle and irrigation system. The plan is to sign it with road closed, double arrow. Motion by Commissioner Dittrich, seconded by Commissioner Williby to authorize Highway Superintendent to draw resolution to abandon road and return the land to adjacent landowners, including bridge. Voting aye: Dittrich, Jacob, Williby and Henery. Nays none. Krebs absent. Motion carried.

**9:30 AM Sidewalks**: Discussion of courthouse sidewalk conditions. During the June 11<sup>th</sup> meeting a discussion and a walk around were conducted by the Commissioners. At that time, it was approved to get bids on repairing various portions of the sidewalk north and west of the courthouse complex. Bids were advertised, no bids were submitted for opening. The Commissioners discussed to continue to look and feel for contractors. No action today.

**9:35 AM** Karter Otte, Insurance Agent from Lincoln Capital Solutions LLC met with the Commissioners today regarding Long Term Care. He would like to visit with employees regarding this, and the ability to have payroll deduction for the product(s). Discussion of products and services. The Commissioners agreed to let him talk with employees. No further action.

**Discussion Extension Office Wages**: a letter received by the Clerk's Office on Thursday last week indicated a \$2.00 – \$2.86 an hour pay increase. Today's discussion regarding the approximate 12+% increase to these wages. Tessa Hain, 4-H Coordinator, met with the Commissioners reporting she believes the increases keeps them consistent with other courthouse employees. However, it was pointed out the increase of \$2.86 takes that individual to over \$1.50 more than the County Officials deputy's highest wage. With recent budget developments the County is currently presented with it is in the best interest of the County to freeze on these wage increases until the budget is approved. Motion by Commissioner Williby, seconded by Commissioner Dittrich to hold on this pay increase until we see how the budget is working out, and approved. Voting aye: Dittrich, Jacob, Williby and Henery. Nays none. Krebs absent. Motion carried.

## **Road Superintendent Report:**

- Oversize Permits: JMS Crane & Rigging requested five (5) oversize permits to move a crane to Thunderhead Tower #67 via Boone County Line at 516<sup>th</sup> Avenue to 836<sup>th</sup> Road east to 519<sup>th</sup> Avenue. Mr. Boggs worked with the crane operator to facilitate a good, safe route. The move was completed. Motion by Commissioner Jacob, seconded by Commissioner Dittrich to approve oversize permits (5) on Road Superintendent recommendation. Voting aye: Dittrich, Jacob, Williby and Henery. Nays none. Krebs absent. Motion carried. (CL0118 to CL0122)
- Culver Project 839<sup>th</sup> Road: Mr. Boggs stated the project was completed on Friday. There was weather coming in and they completed before the weather. It was seeded yesterday.
- 512<sup>th</sup> Avenue: there are washouts. Mr. Boggs will be flagging.
- Clarification on signage Road Closure: Double Arrow Sign, Road Closed underneath it, and three (3) dot DOT sign. Mr. Boggs will discuss with landowners as to how they want it for traveling.

9:58 AM – Executive Session: Motion by Commissioner Dittrich, seconded by Commissioner Jacob to go into executive session for personnel matters. Voting aye: Dittrich, Jacob, Williby and Henery. Nays none. Krebs absent. Motion carried. The four (4) commissioners in attendance met in executive session in the County Clerk's Vault. 10:34 AM – Commissioners Dittrich and Henery left. 10:36 AM Commissioner Dittrich back. 10:37 AM Commissioner Henery and Aaron Boggs attend. (Mr. Boggs steps out.) 10:38 AM Mr. Boggs in. 11:38 AM Mr. Boggs leaves. 11:50 AM Aaron attends. 11:55 AM. Mr. Boggs out. 12:03 PM Motion by Commissioner Williby, seconded by Commissioner Jacob to close executive session and go back to regular meeting. Voting aye: Jacob, Williby, Dittrich and Henery. Nays none. Krebs absent. Motion passed.

Chairman asks Mr. Boggs if he would like to step forward. Mr. Boggs states, "I would like to formerly submit my resignation at this time." Chairman asks for a motion to accept his resignation at this time. Motion by Commissioner Williby, seconded by Commissioner Dittrich to accept resignation. Voting aye: Jacob, Williby, Dittrich and Henery. Nays none. Krebs absent. Motion passed. Clerk asks chairman for a timeline, to which he states immediately.

There being nothing more to discuss.
