July 10, 2018 Antelope County Board of Commissioners Neligh, Nebraska

The Antelope County Board of Commissioners convened in regular session on Tuesday, April 10, 2018 at 8:30 AM in the County Commissioner's Room, Antelope County Courthouse Annex, Neligh, Nebraska. Clerk of the District Court Miscellaneous Fee Report for June was reviewed and put on file.

**Pledge Collateral** was reviewed. There is \$1,305,000/00 pledge plus \$250,000.00 FDIC insured.

Liz Doerr, **Zoning Administrato**r gave her regular meeting report. She presented Zoning June Permit Report. Liz also shared her notice of violation to Upstream regarding destruction of road. The notice gave them until the 17<sup>th</sup> of July to correct violation, she has not made any other action.

**Road Boss Report**: **2009 Mack truck** with sleeper cab is down at RDO. It has got antifreeze blow by, we were hoping it was a compressor, now they are looking for a cracked head or blown head gasket. There is a chance that it could be injector cups. If that is not the case we are looking at about a \$12,500.00 repair bill. Commissioners gave the go ahead to fix.

Gravel Shed: Casey contacted Tony Tscherrin from NDOR. On the walls of the gravel shed, they used to line up the blocks, but it was hard to keep them sealed. Winston-Lippo Contracting, currently erects the gravel sheds for NDOR. The provide the L-shaped wall and hoop building on it. If we provide the foundation, their price on a 30' x 36' is \$29,738. The Dairy Specialist out of Clearwater, the building only (Antelope County doing the floor) the hoop on building and install is \$15,066. The concrete blocks are \$65.00 apiece. The wall would be \$3,100.00. Total cost for a hoop building from Dairy Specialist \$18,200.00 without a floor. The Beckman Lumber quote from last week was with the floor and everything was \$18,525.00 steel building. They would do concrete floor, stem walls, everything. Warranty information from Dairy specialties is 15 years. Beckman is a 12 foot building on a 4-foot stem wall. Discussion if the height was enough. 24' x 36' building – the quote for the stem wall was \$5,700.00 if that is 8 inch it will not be that much to add the extra two (2) inches to the stem wall. The commissioners wondered about the rebar, and 10" walls and the floor depth at 6" concrete. Casey was to check out the specs and report next week regarding stem walls, overhang, floor depth, rebar, etc.

Towards the end of the meeting Casey presented more information regarding the gravel shed: He contacted Ron at Beckman Lumber and received the following information: stem walls were quoted at eight inches with three-foot footing depth, and he stated the ten-inch walls were not a big deal and would charge no more for setting up, but the additional 2 inches would cost accordingly. A six (6) inch floor with rebar was already figured in. 18 feet pad out front he said figure \$2,000.00, worst case scenario \$2,500.00. An overhang on three sides would be \$10.00 a foot (material and labor) approximately \$960.00 for the overhang. Motion by Commissioner Henery, seconded by Commissioner Schwager to approve the quote from Beckman Lumber for the metal gravel shed. Voting aye: Henery, Schwager, Schindler, Jacob and Kerkman. Nays none. Motion carried. In the winter we should be able to use it for some storage. The shed to be built at Neligh Barn.

**Road Use Agreement**: Marlin does not have it all together yet. We are going to do some video of the upgrade roads. Casey had supplied another detail list of concerns after last Tuesdays meeting. Invenergy and IEA did a lot of work on Thursday; actually, they had a lot fixed Tuesday afternoon. (Wednesday was a holiday, July 4<sup>th</sup>).

**Billing Equipment and Man Hour Resolution**: Rates to be considered: Man, Hour Labor \$45.00; Maintainer \$140.00; Payloader \$110.00; Bobcat \$80.00; Vibratory Packer \$80.00; Dump Truck \$95.00, and a clause that states any additional equipment rates to be deemed appropriate. This will be used if someone damages our property, or if Antelope County does work in addition to previous agreed upon projects. Motion by Commissioner Henery, seconded by Commissioner Schwager to approve the fees as discussed. Voting aye: Henery, Schwager, Schindler, Jacob and Kerkman. Nays none. Motion carried. Resolution to be approved next meeting.

**Grading of 529**<sup>th</sup> **Avenue and 849**<sup>th</sup> **Road** project was supposed to start. However, they are waiting on a phone company to move phone lines. It is on hold until phone line is moved.

Map of Priority Roads (Farm to Market): Map presented. Roads through Antelope County in blue are State Highways, the green colored miles are stretches Casey would like to see Hot-Mixed. The orange are roads in which will be saved asphalt and keep up the overlay. Each of these roads could be upgraded once every six (6) years. Casey has marked approximately 75 miles as Priority 1 (hot-mix areas) and 54 miles as Priority 2 (asphalt overlay). All other asphalt roads will be planned to be ground with the millings used on other asphalt projects. Casey would like to see the map he presented evaluated by the board and get suggestions as to what they Commissioners would like to see. This is the start of getting the overall plan for maintaining roads now and in the future. Priority 1 would be immediate attention; Priority 2 would be second attention roads. Casey has documented rural Antelope County by # of houses, asphalt, gravel, quarter, etc. if any of the Commissioners want to refer to this information.

**Packer**: The packer has landed, but they do not have a delivery date as yet. By next week we will have a packer whether it is ours, or a rental. Casey wants to have it before he does the Brunswick Road.

Elgin Chamber of Commerce/Elgin Community Club is planning their annual fund raiser get together. The plan is for August 17<sup>th</sup> with a rain date of August 18<sup>th</sup> from 5:00 PM to 1:00 AM. This is an annual request, there has been no problems in the past. They are requesting a special liquor license. Since the location, Kerkman's Kove is rural Antelope County, the Commissioners need to give consent. Motion by Commissioner Henery, seconded by Commissioner Schindler to approve the Special Liquor License for Elgin Chamber & Community Club. Voting aye: Henery, Schindler, Jacob, Schwager and Kerkman. Nays none. Motion carried.

**Township claims** were reviewed. Motion by Commissioner Schwager, seconded by Commissioner Jacob to pay Township Claims. Making adjustments according to County Treasurer fund balance:

**Bond Refinancing**: Tobin Buchanan, First National Bank, met with the Commissioners regarding the bond refinancing last week. In follow-up an extension of the original bond refinancing date was necessary. Last week is was agreed to go forth with refinancing, and Tobin will be working on moving the bond refinancing as moving forward. Motion by Commissioner Schindler, seconded by Commissioner Jacob "move to amend that Resolution dated August 1, 2017, calling for the early redemption and prepayment of the County's Limited Tax Obligation Jail Bonds, Series 2013, to

extend the date by which the County must issue its Limited Tax Obligation Refunding Bonds, Series 2018, in order for such Resolution to remain in full force and effect, to November 1, 2018." Voting aye: Schindler, Jacob, Schwager, Henery and Kerkman. Nays none. Motion carried.

River Bridge North of Clearwater: The water is eroding away the bank west side of the bridge. In is eroding rapidly. It is still on private property (Dean Thiele ground), however it is threatening the road right of way. In order to maintain the right of way and not have it eroding away, it was discussed the action needed to prevent the inevitable damage. One suggestion was to have the land owner place some concrete slab pieces on the land, so when it gets close the concrete will fall onto the bank to help protect the erosion. The county does not have any concrete chunks, and it was unclear what obligation the county had to stop this eroding. Brian McDonald will be contacted.
