The Antelope County Board of Commissioners convened in regular extra session on Monday, July 11th, 2017 at 8:01 AM in the County Commissioner's Room, Antelope County Courthouse Annex, Neligh, Nebraska. Meeting was called to order by Chairman Kerkman, with the following board members responding to roll call: Schindler, Jacob, Henery, Schwager, and Kerkman. Chairman Kerkman stated that the open meeting laws are posted on the east wall of the Supervisors' room with more copies available at the County Clerk's Office.

Notice of the meeting was given in advance thereof by publication in the four county newspapers, legal newspapers printed and in general circulation in Antelope County, Nebraska as shown by proof of publication filed in the County Clerk's office. Agenda for said meeting was sent to all members of the County Board of Commissioners.

Bruce Ofe, Antelope County **Weed Superintendent** me with the Commissioners regarding his **quarterly report**. During this report, he indicated the intention right now is to not change their budget request from the 2016 asking. In the last couple of years their budget has been very well maintained and has not ran short. In light of this he suggested all chemical be paid out of his budget – including the chemical requested by and used on the county roads. Streamlining this will prevent paperwork chasing back and forth between the two (2) departments. Commissioners are in agreement. The weed department has

had 2 people spraying and have been fairly busy spraying road sides. The plan spray Yellow Flag Iris had been mapped and was set to begin, and the spraying helicopter pilot backed out, so it did not get completed. The NRD will try to reserve some of the grant money and this will be a plan for next year. There are over 80 locations mapped with the Yellow Flag Iris – one patch west of Clearwater was 30-40 acres. They will attempt to spray some of this by ground. They will use Gardon 3, they can spray Purple Lufstrife and Yellow Flag Iris both. The hot/dry weather is not good time to spray, the recent rain may help.

Brian and LeAnne **Brodersen** met with the Commissioners regarding a recent denial of a road access and the subsequent request to change the current **road access**. The access was denied by the commissioners during the June 27, 2017 Commissioner Meeting. When the Brodersen's purchased the rural parcel the road access was there, and they have completed dirt work to compliment the current building plan. With the changing of the road access as it, it changes the dynamics of their building layout plan. After much discussion, it was confirmed the landowners can work with the utility companies, Road Boss and county road employees to move various structures, including some dirt to make the intersection, and road access safe. Currently, there is a telephone line pedestal and possibly other lines running through the location. To obtain proper drainage, a culvert may have to be placed in the area. In the end, the Brodersen's and the Commissioners seemed to agree with the plan. Motion by Commissioner Henery, seconded by Commissioner Jacob to approve driveway access with plan and design agreed upon by landowner and Antelope County Road Boss. Road Boss and landowners will work on the plan to achieve proper and safe access. Voting aye: Henery, Jacob, Schindler, Schwager and Kerkman. Nays none. Motion carried.

The **2008 Crown Vic**, owned by Antelope County Sheriff's Office was advertised for sealed bids to be opened at 9:30 AM, on July 11, 2017 Commissioner Meeting. In all three (3) bids were received and at 9:30 were opened by Commissioner Chairman Kerkman. Motion carried.

Zoning Administrator Report: Liz reported tonight is the public hearing for the Zoning Regulations. It starts at 7:00 PM at the American Legion. Currently, she has two (2) board members involved in the baseball tournament at the Neligh Park. She has a quorum, so they will proceed. Right now, Liz is hoping the Planning Commission will vote on separate items as they go, and then vote on the regulations as a whole. Keith Marvin will be here tonight, and will be at the Public Hearing for the commissioners. If things are returned to the Planning Commission, Mr. Marvin will be needed on a per meeting basis to finalize the regulations. Depending on tonight's outcome, this may go to a Public Hearing for the Commissioners next week.

Casey Dittrich, **Antelope County Road Boss** met with the commissioners and gave the following report.

Started grinding on the Royal Road yesterday. The plan is to do about 3800 feet, which is about $\frac{3}{4}$ of a mile. It starts at the bottom of the hill south of Snodgrass' to Harlan Haake's north driveway. We are going 3 inches deep and it has got pretty good oil on at least half of it, north end is dryer. Oil is ordered for Wednesday, mix it all day, lay it on Thursday. Possibly open the road Thursday afternoon. He inquired about temporarily signing it as "no truck traffic" for a while. It was suggested to keep it closed through the weekend.

While we are in that area, $\frac{1}{2}$ mile north of Harlan Haake to the first mile south of Forbes we can use the rest of the windrow mixture, we can move in with Sidumper's to north of Koenig's for armor coating. With the product we have left, this area will work out very well. Hopefully, this will be a two (2) day project.

Inquiry into the road 8 west of Elgin. Casey questioned mixing on the road. As dry as it has been the commissioners agreed mixing on the road is a very viable option, and the traffic will understand.

Prouty and Spud Trucking has been lined up to have trucks lined up to start shouldering the Brunswick Road, however, this should wait until the Spieker Road discussion today is complete.

Schuchardt Corner is almost complete. We will gravel that this week. It looks good.

Tilden West is coming along well. The 60-foot pilings was not enough, so they had to add on 30 foot.

The Orchard Road 3 miles south was on last year's plan to overlay. I know we are going to spread our oil crew spread pretty thin, that is kind of in the next group of roads. Right now, Prouty has 15 trucks ready to go for hauling. Slowing it down is loading at the pit. There are 3 miles in question one definitely needs to be mixed and overlaid, and we need to shoulder the other miles.

Brunswick Truck – Right now, every one of our 10-yard trucks are broke down – except for the Oakdale truck. I thought it was the worst one. Brunswick's Truck has blown up. There is most likely a hole in the piston. It is getting compression to the crank case and blowing oil right back through the piston and running out the turbo. Probably melted a piston. The Orchard has bad wiring, so you can drive it for a day or two. It seems to break down when it is loaded. Sometimes it takes 20 minutes other times it has to be towed. Clearwater's red truck has a bad cylinder – we are kind of getting by. The yellow truck is in decent condition – we just did brakes on it. Neligh's truck is overheating today. Hopefully it is minor issue. Tilden truck broke a lease spring yesterday, it is down. Elgin truck is working, but maxes out at about 53 mph. In short the 10 yard truck situation is terrible. For the Brunswick Truck, a rebuilt motor through Cornhusker is about \$13,500.00, that is with no accessories, no alternator type stuff. We are 3 weeks out for parts, that is a two (2) year warranty for parts. \$2000.00 to \$2,500.00 in labor. That does not include the turbo that has oil through it. We are looking at the 18,000.00-\$20,000.00 range. The other option is Cornhusker International has a yellow truck. It is an International old state truck. It has all the options, main pump, no PTO, it would be handy for gravel. Purchase price would be \$55,000.00. It is a 2006, 7600 International, 220,000 miles there is no pusher, 10-yard, dump on it, no tandem. Motion by Commissioner Schwager, seconded by Commissioner Jacob to repair Brunswick 10-yard truck. Voting aye: Schwager, Jacob, Schindler, Henery and Kerkman. Nays none. Motion carried.

Tobin Buchanan, with First National Capital Markets met with the commissioners in follow-up of some ideas he brought to the commissioner meeting in June. He requested the commissioners to check into the savings that may be available by refinancing of the bond. The option to do a onetime advance refunding to capture a lower interest rate on the bond purchase. He presented information regarding the amount of savings the advance refund could achieve. The advance refunding is utilized because the bonds are not matured until November of 2018, and the entities are guaranteed their return dollars. Because the interest rate is down from the original purchase rate is the reason for the savings, if the bonds are bought at this time. Accelerated keeps all payments similar to the current pay schedule with a lower payment at the end, recognizing a savings at the end. Uniform will take a little off every payment and recognize a savings on a yearly basis. If Antelope County is interested in this procedure, Tobin would be in contact with Kutak Rock the law firm who would be working on the resolution and the bond

arrangements. Motion by Commissioner Henery, seconded by Commissioner Schwager to give a verbal agreement to proceed with a resolution to initiate the investigation to recognize a significant savings in the refinancing of the Bond money. Voting aye: Henery, Schwager, Schindler, Jacob and Kerkman. Nays none. Motion carried. As explained by Mr. Buchanan this does not obligate Antelope County to act either way. Mr. Buchanan will get the appropriate resolutions to be signed. After they are passed and signed Mr. Buchanan will watch the market and activate the necessary procedures at that time. Signing resolutions does not confirm the participation of the advance refinancing. Chairman Kerkman signed letter "disclosures by underwriters."

Spieker Road (858th Road) Jerry Schwager would like to have a mile ground, and fix the ends of it. Commissioner Schwager stated there is a lot of traffic on that road year-round. Letter from Laura and Bob Spieker. This is a paved road that has been in disrepair for many years. Road Boss stated this road was discussed what we were going to do with the first mile south of Brunswick. At that time, it was suggested by Jerry to use the millings off of 858th Road to use on the Brunswick Road. The plan for 858th Road was to grind the one mile, and to use the millings on the Brunswick Road. However due to opposition and misinformation from the commissioner in the area, this road is a topic of discussion. Grinding of roads has been favorable in the past, using millings and adding gravel helps to maintain those roads. County constituents, Mike Snodgrass, Ray Snodgrass, and Doug Hall all were present for discussion. One (1) mile of 858th road will be ground and left on the road. No further action.

Board of Equalization met from 11:04 AM to 11:46 AM. Motion by Schindler, seconded by Commissioner Henery to go into Board of Equalization. Motion by Commissioner Jacob, seconded by Commissioner Schindler to adjourn Board of Equalization. **Protests** were heard.

Kelly Mueller, Antelope County Assessor presented the **Annual Cemetery Report**. No questions, no action required.

Antelope County Assessors **three (3) year plan** will be presented at the August 1st, 2017 meeting.

Motion by Commissioner Schwager seconded by Commissioner Schindler to **approve Commissioner Meeting Minutes** from May 2nd, 2017; May 9th, 2017; June 6th, 2017 and June 13th, 2017 as presented. Voting aye: Schindler, Schwager, Jacob, Henery and Kerkman. Nays none. Motion passed.

Motion by Commissioner Schwager, seconded by Commissioner Schindler to **approve Board of Equalization Meeting Minutes** from May 2nd, 2017; June 6th, 2017; June 13th, 2017 as presented. Voting aye: Schindler, Schwager, Jacob, Henery and Kerkman. Nays none. Motion passed.

Board of Equalization met from 11:04 AM to 11:46 AM. Motion by Schindler, seconded by Commissioner Henery to go into Board of Equalization. Motion by Commissioner Jacob, seconded by Commissioner Schindler to adjourn Board of Equalization.

Crane for sign pickup: Commissioner Jacob would like to get a crane installed on the new sign truck. The cost is estimated to be about \$9,000.00. This crane would have a 14-foot reach. To reuse the old wench would be \$500.00 to \$1,000.00 cost to have it remounted. The LiftMoore Crane would lift 8,000.00 pounds at three-foot reach. The crane would be reinforced and mounted for the \$9,000.00. Motion by Commissioner Schwager, seconded by Commissioner Henery to purchase and install LiftMoore Crane on new sign pickup. Voting aye: Schwager, Henery, Schindler and Kerkman. Nays none. Jacob abstains. Motion carried.

An estimate to update the **heating unit in the Orchard Barn** was submitted by Hughes Construction, Inc and presented to the Clerk's Office. Commissioner Jacob agreed he had talked to the employees of the barn to possibly get an estimate to replace and update the current heating unit. The estimate was a little over \$ 8,000.00. Because of the time involved it was agreed it would be beneficial to get a couple more estimates on replacing the unit. No further action.
