Chairman Henery stated that the open meeting laws are posted on the east wall of the Commissioner's Meeting Room with more copies available at the County Clerk's Office.

Notice of the meeting was given in advance thereof by publication in the three (3) county newspapers, legal newspapers printed and in general circulation in Antelope County, Nebraska as shown by proof of publication filed in the County Clerk's office. Agenda for said meeting was sent to all members of the County Board of Commissioners. Meeting was available by Zoom.

Zoning Permit Report for July was reviewed and put on file.

Land Owner Lee Meyer met with the Commissioners regarding 846<sup>th</sup> Road (Invenergy Road) and the dust from the Sinclair dirt currently on the road. This road was used during the Construction of Thunderhead Wind Project, and has had dust issues for approximately two (2) years. Mr. Meyer showed a full air filter from his house – which he reports was in his unit for 18 days. Currently, the road is not being utilized for construction, however, the dust is thick and sometimes impossible. It was discussed the Sinclair Dirt takes 18-24 months to settle down. The Invenergy Road Use Agreement was discussed. If it is still under agreement they need to water – calcium chloride the road to help with dust control. Discussion of placing calcium chloride and if it is still under RUA they can reimburse the County. Discussion of recipes and application of the product. Aaron to follow-up and maintain as necessary.

**Warren Snodgrass:** met with the Commissioners regarding Roads in northern Antelope County; i.e., 860<sup>th</sup> Road. Warren owns O&W Dairy in Royal Township. The roads in the area are rutty and impassable at times. After they called there was some improvement for a little while, but it is back to being rough and almost impossible. Discussion of personnel issues – it was stopped before the discussion went further. Discussion of weather, dryness and other issues need to be considered. The landowner stated they had scraped the road. Aaron reminded that is County Responsibility not landowner. Warren asked about a culvert along that road. They reported there are issues on multiple roads in the area. Commissioner Smith mentioned two (2) or three (3) miles of \_\_\_\_\_ Road eats gravel. Aaron did ask the landowner if they would work with packing the road while chopping silage – if the County pulls the road right before. Aaron will be more diligent in the area.

Commissioner Krebs, suggested the County pass a resolution regarding the **150**<sup>th</sup> **Anniversary of Antelope County**. She was recently made aware of the County's anniversary through events at the Antelope County Historical Museum. She had worked on a resolution and wanted to discuss issue further. The County has a couple of options, including doing nothing, passing a resolution solely in recognition of commemoration of the 150<sup>th</sup> Anniversary. Discussion of a plaque commemorating same, passing of a resolution may be enough as it goes into the media at that point.

Antelope County Distress Warrants: Antelope County Treasurer, Deb Branstiter met with the Commissioners regarding the Sheriff's return of the distress warrants by August 1<sup>st</sup>. There is one uncollected distress warrant. Cottonwood Healthcare, \$1,507.46 plus interest. This business went into receivership, and has since been sold. Deb asked the Commissioners to strike the taxes from the records. The Clerk, did not list it on the agenda, so will be added for next week. Joe Abler, County Attorney, will look into this. Tax to be stricken will be on the agenda next week. Deb commended the Sheriff and his office for their due-diligence in the collections.

Guarantee Roofing: Guarantee Roofing's bid was accepted last meeting for replacing/fixing the Annex roof issues. Today, A contract is presented for \$63,105.00 which was the accepted bid. #### ANTELOPE COUNTY LIBRARY ASSOCIATION

THIS AGREEMENT IS MADE AND ENTERED INTO BY AND BETWEEN Antelope County, Nebraska, a Political Subdivision, by and through its Antelope County Board of Commissioners, (hereinafter referred to as "County") and the Antelope County Library Association consisting of the public libraries of the Cities of Neligh, Elgin and Tilden, and the Villages of Royal, Orchard, Clearwater, and Oakdale, each being Municipal Corporations, by their respective Mayors, Chairpersons, and Trustees, respectively.

WHEREAS, Nebraska Revised Statute Section 13-801 Et. Seq., R.R.S. 1943 (reissued 1997), the "Nebraska Interlocal Cooperation Act" authorizes the parties hereto to unite their efforts and resources to accomplish the intent of this agreement; and

WHEREAS, the Antelope County Library Association, by and through their respective community libraries does agree to provide all services and materials to the residents of Antelope County, Nebraska, whom are not residents of the respective Municipal Corporations, under the same terms and conditions as provided to the residents of such Municipal Corporations;

WHEREAS, the Antelope County Library Association's mission statement is to serve the communities of Neligh, Elgin, Tilden, Royal, Orchard, Clearwater and Oakdale as well as all residents of rural Antelope County, Nebraska, as a resource for information, entertainment, cultural opportunity, and educational development, thereby enhancing and enriching the lives of the users. That the libraries within said communities shall be active and progressive institutions providing materials that reflect the needs and interests of its patrons. That said Library Association shall seek equitable funding, share materials and solutions to problems, provide access to resources beyond each of their individual facilities by cooperative agreements with library organizations at the local, regional and state levels and to strive to make use of all possible resources and ideas to meet the needs of the patrons of each of the communities and of the residents of the entire county.

WHEREAS, Nebraska Revised Statute Section 77-3442 R.R.S. 1943 (reissue 1996) provides that \$.05 per \$100.00 of taxable valuation of property subject to the county levy may only be levied to provide financing for the county's share of revenue required under an agreement executed pursuant to the Interlocal Cooperation Act.

Each of the communities, Royal, Orchard, Clearwater, Neligh, Elgin, Oakdale and Tilden by and through their public libraries commonly referred to as the Antelope County Library Association shall provide all services and materials currently available through the public libraries, to non-residents of their community so long as such residents are residents of the county, under the same terms and conditions as such services and materials are provided to the resident of their respective communities.

NOW THEREFORE, in consideration of the foregoing recitals and their mutual covenants here and after expressed, the parties agree as

- That the County agrees to contribute financially to the Antelope County Library Association and agrees to implement a levy not to exceed \$.05 per \$100.00 of taxable valuation of property on an annual basis to the Antelope County Library Association, by paying to the respective libraries of the Cities of Neligh, Elgin and Tilden, and the Villages of Royal, Orchard, Clearwater and Oakdale the applicable amount as provided by this agreement. That a like amount shall be included in the County's budget, reviewable, on an annual basis. This funding to be supplemental funding and not replace other funding.
- That this agreement shall have an effective date of July 1, 2021, and shall continue in full force and effect for a period of one year.
- This agreement shall not be construed as to form an additional political subdivision. The parties hereto agree to comply with any and all laws, rules and regulations, whether same be local, state or federal, required in the administration and execution of the terms and provisions of this agreement. Further, that no party will assign any rights granted under this agreement.

This agreement shall be administered by the Antelope County Clerk, as directed by the respective board of the parties hereto. IN WITNESS WHEREOF, the parties have executed the agreement on the dates appearing directly below their signatures. Dated: July. 2021.
