

The bid is for 2 Cat Snowplow attachment v-plows with Balderson flat hooks at \$16,140.00 each. For a total of \$32,280.00. The V-Plows are on the lot in Omaha and will be delivered to the Neligh Barn. Discussion. Motion by Commissioner Jacob, seconded by Commissioner Williby to approve and purchase the V-Plows per bid. Voting aye: Williby, Jacob, Krebs, Dittrich and Henery. Nays none. Motion carried. No further action.

Hauling Commodities: for the past several years, Lyle and Valerie Hart have hauled commodities for the County. They have recently given a verbal resignation and are no longer able to haul these products for the County. Picking up the commodities at the pre-determined location and delivering them to the Neligh Barn. At which time the Barn employees would spend approximately a day to a day and a half sorting products into individual packages. And multiple barns would spend another half day delivering. Discussion regarding availability of Road and Bridge personnel having to dedicate two (2) plus days to this project – especially during construction season. Discussion regarding if other County personnel might be able to help with this task. Antelope County Assessor and County Clerk volunteered to brainstorm and make some phone calls over the next couple of weeks to figure out a viable plan to keep the program in the County for the benefit of the claimants. They will report to the Commissions in October.

Public Hearing: Road Closing 865th Road north line of Section 34, Township 28, Range 8:

9:35 AM, Chairman Henery opened the hearing. All here. The reason for the hearing was stated as this hearing is a clarification of a road closing resolution from 1994. In 1994, the board of supervisors closed the road and maintained the right of way of the west half of the mile for a mixing strip. Shortly thereafter the Township upheld the closing of said road. Recently, the Zoning Administrator, Megan Wingate, ran into this 'issue' while researching for a zoning permit along this stretch and the landowner wanting to build a house along the western side of this mile stretch. She brought it to the County Attorney, and they (Megan and County Attorney) met with the Commissioners and Highway Superintendent, Brian McDonald regarding the status of the road. A couple of discussions later the County Attorney requested that a public hearing be held to discover and discuss current public interest. A motion was made and a hearing set for 9:30 AM today. Notices were mailed to landowners in the area.

9:37 AM: Chairman Henery called three (3) times for testimony against the closing of the road. No response.

9:38 AM: Chairman Henery called three (3) times for testimony in favor of closing road. Mr. Bob Krutz stated the landowner wanted to keep the road closed. They have access agreements in place.

9:39 AM: Motion by Commissioner Jacob, seconded by Commissioner Dittrich to close public hearing. Voting aye: Williby, Jacob, Krebs, Dittrich and Henery. Nays none. Motion carried. No further action.

Discussion. There has been no comment or written opinions received. Findings and recommendations are to close and relinquish right of way to the adjoining landowners, and for the county not to maintain any ownership. Motion by Commissioner Williby, seconded by Commissioner Dittrich to close road and relinquish right of way to the adjoining landowners and to make sure the road is closed and signed accordingly. Voting aye: Williby, Jacob, Krebs, Dittrich and Henery. Nays none. Motion carried. No further action.

RESOLUTION 2024-10-0001 ANTELOPE COUNTY, NEBRASKA Closing Public Hearing – 865th Road

WHEREAS the Antelope County Board of Commissioners were recently made aware of conflicting information regarding vacation and/or abandonment of 865th Road between 513th and 514th Avenue. The road is located between Sections 27 and 34, Township 28 North, Range 8 West of the 6th Principal Meridian, Antelope County Nebraska.

WHEREAS Antelope County was recently made aware of the retention of the right of way after abandoning said road in 1994. Discussion with the County Attorney, Highway Superintendent and Road Superintendent indicated the need to complete a new public hearing to determine the fate of said road.

WHEREAS it was found to be in the public interest that the County hold a public hearing to continue abandonment of said roadway to the traveling public. Said public hearing was held on September 10th, 2024, at 9:30 AM, in the Antelope County Courthouse Annex – Commissioner Meeting Room.

WHEREAS, during this public hearing the public was allowed to comment on and discuss the future of this mile stretch between Sections 27 and 34 in Township 28, Range 8, West of the 6th P.M., Antelope County, Nebraska.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Antelope County, Nebraska, motioned and approved the closure of said road and the relinquishment of said right of way back to adjacent landowners. A motion was made and seconded to close said mile of 865th Road between 531st and 514th Avenue and revert said road and right of way to the adjacent landowners.

River Road: Clearwater Village Board representative, Marsha Hart met with the Board regarding a portion of River Road (516th Avenue) (going north out of Clearwater) and Nebraska Street. This discussion is in follow-up of a couple of other discussions on these 'roads.' The Village Board is planning on budgeting money during this fiscal year for the River Road Project if they can get an estimate (guesstimate) and help from the County. During recent discussions with County Attorney and Highway Superintendent it was discussed that the County is NOT a contractor, and as such should NOT act in the manner. Contractors are required to have bonds; the County is not bonded in the same manner for this capacity. If there is an accident during construction – who is liable? Before anything else, the Commissioners recommend for the Village Engineer to study and engineer the stretch of 516th Avenue in question and get together with Antelope County Highway Engineer, Brian McDonald and Road Superintendent, Leigh Kluthe to establish a plan to protect the Village, County and all involved. The engineering is essential to keep the road surface and surrounding lands safe and unharmed. When the parties have identified such a plan, we can meet, and discussion can continue. Interlocal agreements with city and villages in Antelope County is an ongoing practice. The County is in favor of assisting if it is warranted by ALL parties. Everyone would like to have the correct fixes including thickness, slope, impaction, width, shoulder width, material used, etc. Timeline depends on reports, plans and conditions.

After this discussion Mrs. Hart mentioned Nebraska Street. The Commissioner assured her they are referring to these projects as a single project. 516th Avenue (River Road) and Nebraska Street. No further action today.

Road Superintendent Report:

Access Permit: Glen Schindler submitted an access permit for an access along 836th Road. This is to establish access to grain bins and have an access so three (3) 90-degree turns would not have to be made to leave the yard. Mr. Kluthe and Highway Engineer, Brian McDonald to look at this to make sure visual clearance is established. With the Highway Superintendent permission - permission is

- granted for 50' from the corner post. No culvert is needed. Road Superintendent recommends approval and has talked to Mr. Dale Schindler. Motion by Commissioner Dittrich seconded by Commissioner Jacob to approve access permit. Voting aye: Williby, Dittrich, Jacob, Krebs and Henery. Nays none. Motion carried.
- Underground Permit: Glen Schindler submitted an underground permit to cross 523rd Avenue to provide electricity to grain bin site. Mr. Schindler has hired Bruce Clark as the contractor. The owner and contractor plans on boring the underground line. Mr. Kluthe voices no issues and recommends approval. Motion by Commissioner Jacob seconded by Commissioner Williby to approve underground permit. Voting aye: Williby, Dittrich, Jacob, Krebs and Henery. Nays none. Motion carried.
- Underground Permit: Thiele Dairy submitted an underground permit to cross 848th Road between Sections 24 and 25, Township 25, Range 8 West of the 6th PM, Antelope County, Nebraska to provide electricity. Thiele Dairy has hired Boyd's Electric as the contractor. The owner and contractor plans on boring the underground line. Mr. Kluthe voices no issues and recommends approval. Motion by Commissioner Jacob seconded by Commissioner Williby to approve underground permit. Voting aye: Williby, Dittrich, Jacob, Krebs and Henery. Nays none. Motion carried.
- Motor Grader: the CAT Motor Grader bought in 2021 has been down for going on three (3) weeks. This motor grader is under warranty, and the dealer cannot figure out what is wrong. Mr. Kluthe reiterated that this is our BUSY construction season and CAT agreed to a two (2) day loaner. Discussion with Commissioners regarding warranty. A call was made to Eddie Bomar, and Dave Prauner, CAT representatives. The County is authorized to utilize the 'loaner' until the County's 'broken' motor grader is fixed and returned to the County.
- **Armor Coating:** Mr. Kluthe reports he has approximately 21 miles of armor coating. 5 miles on Copenhagen Road 531st Avenue (856th 863rd Road); Plainview Golf Course Road 865th Road (531-532nd Avenue); ½ mile by Brunswick (863rd Road -526th Avenue to Brunswick); 7 miles 836th Road (514-521st Avenue); 839th Road Elgin-523rd.5 Avenue; 513th Avenue 858th-859th & 862nd-863rd Road; 527th Avenue (839th 840.5 Road).
- **Pickup for Mechanic:** Mr. Kluthe is looking for a vehicle for the mechanic to drive. He has found a couple of vehicles online, which seem to be exactly what he is looking for and would fit within the budget. Mr. Kluthe requested permission to continue to look for such a vehicle. Discussion. It was discussed that he could continue to look and inspect and possibly make an offer if the deal is what the County needs. The Purchasing Act states between \$10,000.00-50,000.00 three like informal bids. He was instructed to keep conversations with the Commissioners open.
- 846th Road 514th 515th Avenue: Discussion. Planning to cap the top road surface of this stretch. This has a Sinclair base. Discussion.
- **Striping center of School Road**. The Commissioners believe a center dotted reflective line on this stretch would add night vision clarity and is probably the best option for now.

G-Works: Antelope County Assessor, Kelly Mueller-Oltjenbruns, met with the Commissioners regarding the current GIS program utilized by Antelope County Assessor. Mrs. Oltjenbruns stated the g-works program is maintained by her office and is a huge asset to the County. However, over the last five (5) years the support has gone down, and the cost has increased greatly. There are months when the site is down more than it is available. Because of this she has been researching and reviewing other options. The G-Works program has a Road and Bridge tab and multiple other layers and tabs. With each layer G-Works assesses a creation and maintenance fee. Currently, the agreement has an expiration date of July 1, 2025. However, earlier this year the Road and Bridge Department requested to continue the road and bridge tab. To date that tab has not been utilized or marked. During research, Mrs. Oltjenbruns has been working with Snider-Beacom, who offer a similar product with more support and is more affordable. There is an initial startup cost of \$15,400.00, which they will waive if we sign a contract. Snider-Beacom offers tabs for assessor, road and bridge, zoning, election, etc. They quoted \$16,596.00, \$17,000.00, and \$18,000.00 each year for the 1st, 2nd and 3rd year. Snider Beacom will provide 48 hours of instructional use for offices trying to utilize the tabs. All the tabs are included in the quoted rate. In comparison, G-Works assesses \$5,000.00 a year per tab with the initial remaining close to \$20,000.00. Snider-Beacom plans to start initializing the files as soon as a contract is signed. The will go live sometime early next spring and be in full force and ready for a July 1, 2025, start date. Mrs. Oltjenbruns has completed extensive review of various GIS products and believes the Snider-Beacom is the best option for ALL of Antelope County's needs, including the Simple Signs program currently operated by the Road and Bridge Department. Motion by Commissioner Krebs, seconded by Commissioner Williby to approve contract, authorize Chairman to sign and for the Assessor to move forward with the change from G-Works to Snider-Beacom. Voting aye: Williby, Dittrich, Jacob, Krebs and Henery. Nays none. Motion carried.

Budget Discussion: Budget hearing is Tuesday, September 17th, 2024, at 8:00 AM. The budget was balanced as of figures discussed in previous meetings. Should be a short hearing as the asking and levy are both down from last year. All the Board members should try to be in attendance.

There being nothing more to discuss.

Motion was made by Commissioner Williby, seconded by Commissioner Jacob to adjourn. Voting aye: Williby, Dittrich, Jacob, Krebs and Henery. Nays none. Motion carried.

The meeting adjourned at 11:27 AM.
