WHEREAS, the budget figures reflect a 1% levy increase, and

WHEREAS, the budget for the Fiscal Year July 1st, 2021 to June 30th, 2022 is evidenced by the Budget document, and the same hereby was adopted as the Budget for Antelope County for said fiscal year.

WHEREAS, Reappraisal Fund in the past has been serving as a separate Fund and a tax asking Fund, during the previous fiscal year was reviewed and deemed not to be a tax asking authority; and.

WHEREAS, the reappraisal would be more applicably funded as a function under the General Fund; we authorize the Treasurer to transfer funds from the Reappraisal Fund (1100) to the General Fund (0100); it is the Budget Making authority order to have the Antelope County Treasurer receipt all future receipts (from Reappraisal Fund) into the General Fund;

WHEREAS, the Antelope County Budget making authority, desires that the reappraisal be budgeted as Function Number 643 under the General Fund (0100) of the Antelope County 2021-2022 Budget. The Assessor is hereby authorized to expend the amounts herein appropriated to them during the fiscal year beginning July 1st, 2021, and ending June 30th, 2022.

ALSO, WHEREAS, Antelope County was awarded funding from the America Rescue Plan Act, and,

WHEREAS, Antelope County will be receiving and spending these funds, we wish to hereby create and include the Fund of 2580 into the Fiscal Year July 1st, 2021 to June 30th, 2022 budget;

WHEREAS, the offices, departments, activities and institutions herein named are hereby authorized to expend the amounts appropriated to them during the fiscal year.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioner of Antelope County, Nebraska to adopt said resolution. Passed and adopted this 14th day of September, 2021

Road Superintendent Report:

- Permit Resolution: Aaron asked about the maintenance of culverts after placement. Discussion of various scenarios and avenues. Aaron stated it has been the County's 'policy' that all maintenance of culverts is the land owner responsibility. However, if the resolution is updated to include verbiage of future maintenance belonging to the landowner, what liability lies on the County, and what would be the course of action for the County, if the land owner does not maintain said culvert. The County would continue to place the initial culvert, that way we have the assurance the culvert was placed correctly.
- Maintenance Policy-Aaron is continuing to work on this resolution.
- Discussion of updating the Road Closures in the Roads book.
- West of Riley Smith's on Baker Road should be a 'T' intersection there is not a sign Aaron will work on placing it.
- Virgil Carpenter there is a road out by Virgil Carpenter that was 'improved' by Invenergy for access to three (3) turbines, which are sand or even two (2) trail roads. The road actually does not go to any destination except for the wind turbines. Signing of the road was discussed. It cannot be labeled as no outlet, as it actually does do somewhere. Aaron is suggesting something like 'Gravel Ends Ahead'.
- Food Pantry boxes per population. It can be distributed to anybody. Commissioner Pedersen will try to contact someone regarding same.
- Trucking of Commodities. Aaron asked about saving hiring of the hauler, and utilizing Antelope County man power to transport the commodities.
- Dusty roads were discussed. Dust control was placed by 846th Road (Lee Meyers House-Invenergy Road). Aaron reported he is getting more and more dust complaints. Discussion of replacing a hard surface with dirty gravel and trying to eliminate the excess dust. Discussion of utilizing an October 1st deadline for dust control placement. This will be included in the maintenance policy.
- Old Highway 14, 'No Truck Traffic' Commissioner Smith did see this sign posted on a gravel county road near Sioux City. He is not sure if possibly these were grandfathered in. When checking with Dakota County they thought maybe this had been in place for approximately 15-20 years. Aaron said possibly we could do a weight limit truck sign. No action today.

No other issues to discuss.
