- Clearwater Bridge: The old wing is out, and are driving the new wing. Finish on that is within the next two (2) weeks.
- County Line Tube: (Meyer Tube) is open. Final grade, and seeding needs to be completed on borrow site and ditches.
- Kevin Klabenes bridge is open. Some rip-rap needs to be completed. Two lanes are open.
- Access Permit: Joe Funk submitted an access permit for the S½NE¼ for the storage unit along D Street in Section 28, Township 25, Range 6, West of the 6th P.M., Antelope County, Nebraska. Joe is the contractor and owner he will provide the culvert and install. Casey recommended to accept as submitted. Motion by Commissioner Henery, seconded by Commissioner Jacob to approve Access permit as submitted. Voting aye: Henery, Smith, Jacob, Bentley and Borer. Nays none. Motion carried.

- Casey discussed the **road south of Clearwater** regarding some recent posts and discussions regarding same. Everything being done on that road is Contractor Work. The people attacking were at and participated in a meeting of the Commissioners in this room. The County invested less than \$5,000.00 a mile on this project. Contractors are working, and the County is aware of the situation. We are hoping to get things done in a timely manner.

- 846th Road will be rocked from County line to County line.
