Juvenile Diversion: During recent correspondence with The Madison County Attorneys Office has requested participation of Antelope County the district Juvenile Diversion Program. Antelope County has participated in the past, and at present County Attorney, Joe Abler expresses Antelope County has no desire to continue participation, as there is no interest and the officers that had coordinated the program has lost interest and no authority from the varying offices. Currently, Sherry Petersen with the Madison County Attorneys office is reaching out to the schools to have a program in which a certified counselor in the Antelope County Schools. Currently, Sherry is exploring all options so as to not severe Antelope County's participation in the current program. It was discussed whether Madison County might be willing to supply an officer to help in the Antelope County Diversion Program. As a whole the Commissioners seemed to be in favor of continuing the agreement and program. It was requested of Antelope County Attorney to speak with Sherry Petersen regarding assistance via an officer to administer the Antelope County Diversion Program. Joe Abler will follow-up with the commissioners during the November 13th, 2018 meeting.

Royal North Bridge Mr. Bob McLaughlin, Resident Claims Representative has emailed in County Attorney, Joe Abler. At present the two (2) have not gotten together to discuss the bridge and possible action to resolve this problem. This bridge was damaged in July of 2017, said bridge was damaged by an impaired driver. The damage that occurred damaged the integrity of the bridge and the county opted to fix the project by utilizing a different type of structure. The insurance company is trying to establish the bridge had depreciated out and was no longer as valuable. The offer presented did not correspond to action the Commissioners wanted. They have asked the county attorney to proceed with a more favorable negotiation. County Attorney, Joe Abler was in attendance today. He will try to contact the Insurance Adjuster, and will meet with the Commissioners in executive session in November.

Road Boss Report:

Under road Permit: Permit was submitted by Elkhorn Rural Public Power District to place a two (2) inch PVC pipe underneath 846th Road in the SE¹/₄ Section 33, Township 25, Range 8 and the NE¹/₄ Section 4, Township 24, Range 8. The county currently has a 48-inch minimum, it is mentioned on the permit of 42 inches. Owner and Tenant is Knievel Farms Inc. The purpose of the pipe is to run electricity to pivot. Motion by Commissioner Schindler, seconded by Commissioner Schwager to accept the permit with the 48-inch minimum. Voting aye: Schindler, Schwager, Henery and Kerkman. Jacob out of room for vote. Nays none. Motion carried.

Casey discussed with the commissioners regarding the **road access permits for Keystone XL Pipeline**. These permits have been at the Clerks Office since July. The permits numbering 72 total run along the proposed pipeline route. This route however is an easy direct path, in consideration of the topographical measures of the route. In the proposed line there is no consideration as to open roads and access currently in place. He has spent roughly 10-12 hours looking at these permits. Some are clearly marked, and others there is nothing concrete to start with. Everything NW of Highway 20 and East of Highway 14. The middle stretch is still left to do. The Road Use Agreement is more of a priority for Casey then the access permits. However, they have not updated the original RUA as requested in the beginning of the process. Casey plans to finish up the route today, so he will have a handle on the permits as is. The permit is not approved until after they are approved and Chairman has signed. Casey has written if the crossing is ok or not acceptable. The permits will be approved as Casey gives permission.

The **55/45 Bridge Matching Program** was discussed in a recent NACO meeting. It is believed there is a process open for application at this time. The process may be open until November 30, 2018. Casey was not aware of this current phase, and will check with Brian McDonald as to the availability and application.

The bridges that have been approved (bridges on the Knox County Line) have to be completed by December 31, 2019. We believe the cap to each payout is \$150,000.00.
