## **Road Superintendent Report**: Aaron met with the Commissioners:

- Oversize Permits: True Steel Crane. Road Superintendent voices no issues. Motion by Commissioner Smith, seconded by Commissioner Jacob to approve two (2) oversize permits. Voting aye: Smith, Jacob, Pedersen, and Henery. Nays none. Krebs absent. Motion passed.
- Stop sign: 844<sup>th</sup> and 512<sup>th</sup> Avenue concerned citizen has asked about stop sign replacement. Aaron stated there is no 'proof' there was a stop sign there. This intersection is on a list for Brian to do a study to establish the need to place a sign on this intersection.
- Striping Summerland School Roads: Aaron reports he has had a number of calls concerning the striping of the school roads in the Summerland School area. (Orchard and Summerland Roads) This has been discussed previously. Aaron is checking with Brian McDonald regarding traffic counts in the area, and the wideness of the road. Aaron is interested in purchasing a pickup for the Road Department and an additional crane for an additional sign truck. After discussing mileage the Board showed no interest in purchasing the pickups in question. The Board requested Aaron to continue to look for a truck that would have the crane and a bucket truck as a single unit. Aaron is to report next week.

**Health and Human Services Ceiling**: In follow-up of discussion from last week, Aaron Kinnan was asked to and submitted an updated bid for lowering/replacing the ceiling in the Antelope County Health and Human Services Office. The bid was opened today. The ceiling in this office was bid in 2019 – at that point a contractor was selected based on the bidding process. The awarded contractor never completed the work. Mr. Kinnan is contracted to work on other areas of the Courthouse. The discussion was tabled until we could check with the State Auditor's Office. We will check and discuss again in December.

Commissioner Jacob asked if there where issues with a grader and a truck. Grader is being gone through to see what is wrong and it will cost to fix it. Commissioner Jacob requested the grader go to grand island if it needs to be fixed. Dump Truck; international dump truck – warranty issue – warranty expired in July – it was in the shop on August 2<sup>nd</sup>. Overall, the dump truck has had enough repair bills – nobody had interest in adding another hefty repair bill to the truck.
