Road Boss Report: Fractured Critical Bridge map presented.

Tree Policies: There have been ten (10) tree problem areas identified. Because of the different issues including election and harvest we will work on this in the coming week. During the identification process and talking to some of the landowners some of them have already acted to correct the problem. We will send letters out before following-up during the December meeting.

Underground Permit: Motion by Commissioner Schwager, seconded by Commissioner Jacob to approve the application for permit submitted by John Beckman to place a permanent electric line beneath 524th Avenue crossing in the NE¼ of Section 32, Township 23, Range 6 West of the 6th P.M., Antelope County, Nebraska. This line must be signed and signage must be maintained. John Beckman – owner, electric line to be used for center pivot irrigation, all work to be done according to State and County specs. Voting aye: Henery, Schwager, Schindler, Jacob and Kerkman. Nays none. Motion carried.

Bridge County Matching: Casey Dittrich has been working with Brian McDonald to identify some bridges that may qualify above other submitted bridges. Antelope County received the bridge matching acceptance last qualification. Casey requested the Commissioners make a decision. The qualifications is they have to be deemed fractured critical before they would qualify. A map was presented; however, it was not an easy read on the screen. Casey showed the map on his laptop. There was general discussion on multiple bridges.

RUA: Due to the Conditional Use Permit public hearing Casey wanted to discuss the Road Use Agreement for the Thunderhead CUP. He has been working with various counties to help improve any future road use agreements. If the CUP submitted by Invenergy is accepted Casey is requesting a means to put more teeth into the RUA to help with any problems that may arise. Including progressive disciplinary actions as a whole. He will discuss further during the public hearing.

Dean Smith met with the Commissioners regarding **Upstream Road Issues**.....he asked if the roads that were closed by Road Boss last week if they had been opened. Casey responded they had been opened after proper gravel and drying of the roads occurred. Dean supported the comments made by Casey regarding the RUA. Dean stated he did not think the public hearing should proceed today, because of deficiencies in

the hearing notice and deficiencies in the current Upstream Agreement with the County that to his findings are not complete yet. The notice stated public comments will be accepted until 4:30 PM on Monday, November 12th, 2018. When in fact the Courthouse was legally closed.

PUBLIC Hearing Discussion: Joe Abler met with the commissioners regarding the courthouse being closed yesterday and the Public Hearing Notice statement of accepting comments through Monday, November 12, 2018. Joe advised the Commissioners it was up to them, but the courthouse was closed. A discussion with the Commissioners and County Attorney was held. Liz Doerr, Zoning Administrator noted that written comment is accepted during the public comment part of the public hearing. Motion by Commissioner Schwager, seconded by Commissioner Henery to postpone Thunderhead Public Hearing until December 4th, 2018, at 8:00 AM. Voting aye: Voting aye: Henery, Schwager, Schindler, Jacob and Kerkman. Nays none. Motion carried. It was later discussed the Public Hearing will be moved to 10:00 AM due to various deadlines, and preparation details.

CUP Public Hearing Thunderhead postponed.

Recent discussion on the **Juvenile Diversion Program**. County Attorney Joe Abler said he did not have any support since the deputies that worked with the program are not interested in continuing. After corresponding with Sherry Petersen at the Madison County Attorneys Office they are willing to support the program if the Attorney is willing to refer juveniles for program participation. Multiple conversations regarding same have been back and forth. County Attorney Joe Abler, has agreed that participation in the Diversion Program working with the Madison County Officers. The County Attorney will work with the Sherry Petersen regarding future references for the Juvenile Diversion.

Motion by Commissioner Schindler, seconded by Commissioner Jacob to included paying the Matteo Sand & Gravel claim from the Road and Bridge Fund (Matteo Sand & Gravel - \$2252.76). Voting aye: Schindler, Jacob, Henery, Schwager, and Kerkman. Nays none. Motion passed.

Motion was made by Commissioner Henery seconded by Commissioner Schwager to **adjourn**. Voting aye: Schindler, Jacob, Henery, Schwager, and Kerkman. Nays none. Motion passed.
