November 14th, 2023 Antelope County Board of Commissioners Neligh, Nebraska

The Antelope County Board of Commissioners convened in regular session on Tuesday, November 14th, 2023, at 8:00 AM in the County Commissioner's Meeting Room, Antelope County Courthouse Annex, Neligh, Nebraska. The meeting was called to order by Board Chairperson, Charlie Henery with the following board members in attendance: Williby, Jacob, Heithoff and Henery. Krebs absent. Vice-Chairman stated that the open meeting laws are posted on the east wall of the Commissioner's Meeting Room with more copies available at the County Clerk's Office.

Notice of the meeting was given in advance thereof by publication in the three (3) county newspapers, legal newspapers printed and in general circulation in Antelope County, Nebraska as shown by proof of publication filed in the County Clerk's office. The agenda for said meeting was sent to all members of the County Board of Commissioners.

Pledge of Allegiance was recited.

Agenda: Motion by Commissioner Heithoff, seconded by Commissioner Jacob to approve agenda as presented. Voting aye: Williby, Jacob, Heithoff and Henery. Krebs absent. Nays none. Motion carried.

Road Superintendent Report:

- Underground Permit: Ted Hughes with Blackstrap submitted two (2) underground permits for crossing Airport Road in the NE¼ 32-25-6 & SW¼ 32-25-6 for a natural gas line to supply natural gas to Blackstrap Inc at 84601 Airport Road. Mr. Hughes is trying to run heat to his proposed shop. Motion by Commissioner Williby, seconded by Commissioner Jacob to approve both underground permits to be bored. Voting aye: Williby, Jacob, Heithoff and Henery. Nays none. Krebs Absent. Motion passed.
- Underground Permit: 3 Permits Great Plains Communication these permits were submitted and paid for in 2022. Mr. Boggs has been working with Great Plains, and they have suspended the project for now. Mr. Boggs and Great Plains wished to have these permits tabled. Motion by Commissioner Williby, seconded by Commissioner Heithoff to table the permits at this time. Voting aye: Williby, Jacob, Heithoff and Henery. Nays none. Krebs Absent. Motion passed.
- Oversize Permit: Winslow Crane Service submitted an oversize permit to move an oversize crane to Tower 318. Mr. Boggs reports no issues and
 the move was carried out safely, and without incident. Motion by Commissioner Williby, seconded by Commissioner Jacob to approve oversize
 permit. Voting aye: Williby, Jacob, Heithoff and Henery. Nays none. Krebs Absent. Motion passed.
- Underground Permit: Dennis Sanne submitted an underground permit for 514th Avenue in the SW¹/₄ Section 14, Township 24, Range 8, West of the 6th P.M., Antelope County, Nebraska. This is to convert irrigation motor from diesel to electricity. Voting aye: Williby, Jacob, Heithoff and Henery. Nays none. Krebs Absent. Motion passed.
- Underground Permits: 862nd Road: Turnkey submitted two permits to place fiber across and along 862nd Road between Section 8 and Section 17, Township 27, Range 6, west of the 6th P.M., Antelope County, Nebraska. These permits were approved verbally, before last weeks meeting, however in the interim, Mr. Boggs witnessed the fiber was not bored, and was in fact trenched. Late October-early November is not a good time to trench as it leaves to much instability on the road during the winter. Mr. Boggs has emailed the submitting entity, who was not aware of the trenching, and is trying to figure out a remedy. The Commissioners requested Mr. Boggs to continue to work with the submitter on a workable solution, and to keep the commissioners posted. This will be back on the agenda for next month. No further action. County Attorney will be informed.

Unpaid bills submitted by Taxpayer: during last week's meeting discussion of tire and blade bills submitted by Robert Johnston was discussed. The Commissioner had requested a claim be submitted to insurance. Insurance had denied the claim as the County had no prior knowledge of the exposed posts. Mr. Johnston met with Commissioners today to express his disappointment. Quoting state statute 39-1811. The Commissioners reiterated this was out of their hands – and the County would not be paying the bill(s). Is this would set a precedent, that could be detrimental to the financial stability of the County. Mr. Johnston was given a copy of the correspondence from NIRMA. No further action.
