The Antelope County Board of Commissioners convened in regular session on Tuesday, December 10th, 2019 at 8:01 AM in the Commissioner Meeting Room, Antelope County Courthouse, Neligh, NE.

Elm Township Road Closings 847th & 848th: These Road Closings were petitioned for closing and the public hearing was on September 3rd, 2019. Because of the situation and the lack of information of the current Commissioners. Discussion held about continuing to gather information, review of the verbiage of the public hearing, Highway Superintendent Report regarding same. Motion by Commissioner Pedersen, seconded by Commissioner Jacob to postpone until January 7th, 2020 at 9:45 AM for review and information. Voting aye: Jacob, Henery, Pedersen and Krebs. Nays none. Smith absent. Motion carried.

Road Superintendent Report:

- **OT/Compensatory Time:** Mr. Dittrich is requesting the employee choice to continue. The Commissioners agreed during the December 3rd, 2019 meeting to authorize the continuance for the month of December. Casey presents today to request continuance of this for the future. Discussion. Motion by Commissioner Henery, seconded by Commissioner Jacob to continue overtime/compensatory time for Road and Bridge Employees choice by month, and have the Clerk prepare a resolution authorizing same. Voting aye: Jacob, Henery, Pedersen and Krebs. Nays none. Smith absent. Motion carried.
- **TransCanada access Permits:** Casey has reviewed the permits submitted by TransCanada. They did not mark these crossings. He has multiple questions and has called TransCanada who will meet with him at a later time. No action today.
- Singing Bridge: Boe String Arch Bridge Casey requested input from the public and Commissioners as to what needs to or will happen to the bridge, which was misplaced during flooding in 2010. It currently is a water flow inhibitor as far as ice jam, etc. To move the bridge it will take a 75 ton crane. Casey has spoken with a Contractor and is trying too work out a way in which the

County Employees can help to alleviate additional expenses and budget damage. Casey requested the Commissioners are willing to move forward on removing the bridge from it current location. An option is to move the bridge to Neligh and place it at a later date. The Board is willing to move forward – keeping the cost/budget in mind.

• **Bridge by Georgiann Hoefer:** Commissioner Jacob mentioned needing a bridge marked. It is not marked; he would like to see the yellow and black signs. Highway Superintendent does not recommend railing because of farm traffic.
