Personnel Handbook: Antelope County's Employee Handbook is antiquated and outdated. The Antelope County Officials are requesting to work towards updating the policy and was wondering if a committee could be formed to work to update the current policy. The Commissioner's agreed to set a committee of Kelly Mueller-Oltjenbruns, Deb Branstiter, Charlie Henery, Leigh Kluthe, Kathy Ollendick and Lisa Payne to work on a proposal to update the current Employee Handbook. The Committee shall work through this and present it to the Commissioners next spring for approval and adoption.

Executive Session: Antelope County Board of Commissioners met in Executive Session regarding personnel issues. 9:02 AM Motion by Commissioner Heithoff, seconded by Commissioner Jacob to go into executive session for personnel issues. Voting aye: Jacob, Heithoff and Henery. Krebs and Williby absent. Nays none. Motion carried. Commissioners Jacob, Heithoff, and Henery and Clerk, Lisa Payne met for approximately 10 minutes. 9:12 AM: Motion by Commissioner Heithoff, seconded by Commissioner Jacob to close executive session, and go back to regular meeting. Voting aye: Jacob, Heithoff and Henery. Krebs and Williby absent. Nays none. Motion carried. Chairman Henery stated no action was taken during executive session.

9:15 AM: Bobcat Bid Opening: Antelope County Sheriff requested to purchase a bobcat to assist in snow removal and yard work at both the Law Enforcement Center and Courthouse. Coordinating with Road and Bridge seems to be a struggle. The Sheriff published and posted the bid for two (2)

weeks. The only bid received was from Kayton International. The lone bid was for a 2021 Bobcat immediately available, for \$47,000.00. Discussion on the merits of the Bobcat, need and usefulness. All agreed the \$47,000.00 was a very fair price. Commissioner Henery asked about a warranty. Warranty information was not included in the bid. Motion by Commissioner Jacob, seconded by Commissioner Heithoff to accept and bid for 2021 Bobcat for \$47,000.00 from Kayton International. Voting aye: Jacob, Heithoff and Henery. Krebs and Williby absent. Nays none. Motion carried.

Brent Niese, representing **Summit Carbon Solutions**, met with the Commissioners regarding the current project update. Currently 88% acquisition is signed up. They have held a public hearing for the Conditional Use Permit and received approval from Antelope County Planning and Zoning. They will be planning and holding a conditional use permit hearing with the Commissioners next year (2024). Nebraska does not have a state permit for CO2 pipelines. Holt County does not have zoning, so Summit Carbon Solution has met the requirements for them. Stanton and Dakota Counties are still working with the Zoning Administrator for conditional use permits. Before going live, the pipeline will be tested at its maximum for hours to test its probability. Construction is set for 2025, and minimum set-back from a residence is 350 feet. Ploom studies should be forthcoming. Summit Carbon Solutions will be working on verbiage of road use agreements etc. and may be presenting in the first half of 2024. No further action today. Mr. Niese addressed the use of ethanol in sustainable aviation fuel. Essentially, creating a larger market for ethanol.

Nebraska Safety Council: John Lefler met with the Commissioners regarding the membership of Antelope County in the Nebraska Safety Council. Antelope County has membership here because of and facilitated by NIRMA. He wanted to make sure we were aware of Nebraska Safety Council and the benefits offered. Road Superintendent Report:

- Access Permit: Everett Meyer submitted an underground permit for access to 519th Avenue in the SE½ Section 9, Township 28, Range 7, West of the 6th PM, Antelope County Nebraska. Purpose is to establish a field entrance. Mr. Boggs expressed no issues and culvert has been placed. Motion by Commissioner Jacob, seconded by Commissioner Heithoff to approve access permit. Voting aye: Jacob, Heithoff and Henery. Nays none. Krebs and Williby absent. Motion passed.
- Oversize Permit: Permit submitted by Nathan Bach of Bach Farms Custom LLC. The oversize permit is to move a crane from Tower 303 to Tower 203. Utilizing west on 839th Road, Highway 14 north to Highway 275 east to Highway 45 South, west on 836th Road, and south to 533rd Avenue, west on 835th Road, to 530th Avenue north. Mr. Boggs voiced no issues and recommended approval. Motion by Commissioner Jacob, seconded by Commissioner Heithoff to approve oversize permit. Voting aye: Jacob, Heithoff and Henery. Nays none. Krebs and Williby absent. Motion passed.
- Tree Mr. Boggs reports he will be following up on the tree issues worked on last winter/spring. He believes he has about 60% participation at present.
- **Sign Program** Mr. Boggs reports the Road and Bridge crew should be working on the culvert bridge mapping through the GIS program. Mr. Boggs is hoping to make great strides this winter, providing the snow fall is manageable.
- Marking of bridge/culvert reported there is a box culvert or bridge wall that needs to be flagged on the road going east of Boyd and Carolyn Pedersen's place west of Neligh on Highway 275.00 Mr. Boggs will check it out. 853rd Road out by David Buller access permit last week.
- No further report.

Zoning Administrator Report: Ms. Wingate followed up the conversation with Brent Neece regarding the CO2 Pipeline. Nebraska does not have regulations on pipelines; however, she has checked with the Public Service Commission at this time – they are making no recommendations. She confirmed there is a shut off valve in Antelope County which is 12.1 miles from the shut off valve in Holt County and 18 miles from the shut off valve in Pierce County.

No further report.

Warranty for the Bobcat: Sheriff Moore presented a quote from Kayton regarding the warranty for the Bobcat. \$1,600.00 for 60 months/2000 hours or \$3,600.00 60 months/3000 hours. Motion by Commissioner Heithoff, seconded by Commissioner Jacob to approve. Voting aye: Jacob, Heithoff and Henery. Nays none. Krebs and Williby were absent. Motion passed.

Personnel Issues: Sheriff Moore met with the Commissioners regarding a personnel issue. A deputy from another county has reached out to Sheriff Moore regarding possibly working for Antelope County. He is certified and has training and ready to plug and play. However, he currently is under contract with he County he is working in. He believes the County can buy out his contract (less than \$20,000.00). The Sheriff reminded the Commissioners he has worked short for the majority of 2023. He believes this to be available money to purchase the contract and remain in budget on his salary. Discussion. The Commissioners agreed it seemed agreeable, as Antelope County would not have to chance at the possibility of him not obtaining his certification. Motion by Commissioner Heithoff, seconded by Commissioner Jacob to approve buyout of the contract and hiring if all works with Law Enforcement Center. Voting aye: Jacob, Heithoff and Henery. Nays none. Krebs and Williby were absent. Motion passed. The Sheriff will work with the County Attorney on drawing/writing contract.

Royal Site – **radios** had to be fixed. Platte Valley is doing work, and it seems to be going well. The radios are working great. Repeaters are starting to age and may need replacing soon. The sheriff is estimating a \$30-40,000 repair bill. The Sheriff is estimating about \$30,000.00 for repeaters in the northern part of the County.

Willowdale Tower: the guide light on this tower was not working. The Sheriff had Platte Valley Communications give an estimate. They report the photocell and 2/3rd of the LED lights are non-functional. The system as a manufacturer date of 2010. The quote to get the lights working was presented at \$9,315.00. Discussion. Motion by Commissioner Heithoff, seconded by Commissioner Jacob to approve light fixes ASAP. Voting aye: Jacob, Heithoff and Henery. Nays none. Krebs and Williby were absent. Motion passed.

Flooding issue on property. Robert Petersen: in follow-up of a Board discussion in November, Mr. Petersen presented neighbor letters regarding the opportunity to drain the water to neighboring properties. Mr. Petersen has checked with the NRD and NRCS regarding flooding of his property in NE¹/₄, Section 27, Township 28, Range 8, West of the 6th P.M., Antelope County, Nebraska. Further discussion and fact presentation. The recommendation of the Road Superintendent and the Commissioners was for Mr. Petersen to add a riser pipe into the middle of the wet area and drain it into the County culvert. Mr. Petersen agreed and has contracted with John Prouty to do dirt work. Mr. Boggs asked Mr. Petersen to have Mr. Prouty call him when he is getting ready to do dirt work.

Adjournment: Motion was made by Commissioner Jacob seconded by Commissioner Heithoff to **adjourn**. Voting aye: Jacob, Heithoff and Henery. Nays none. Krebs and Williby were absent. Motion passed.
