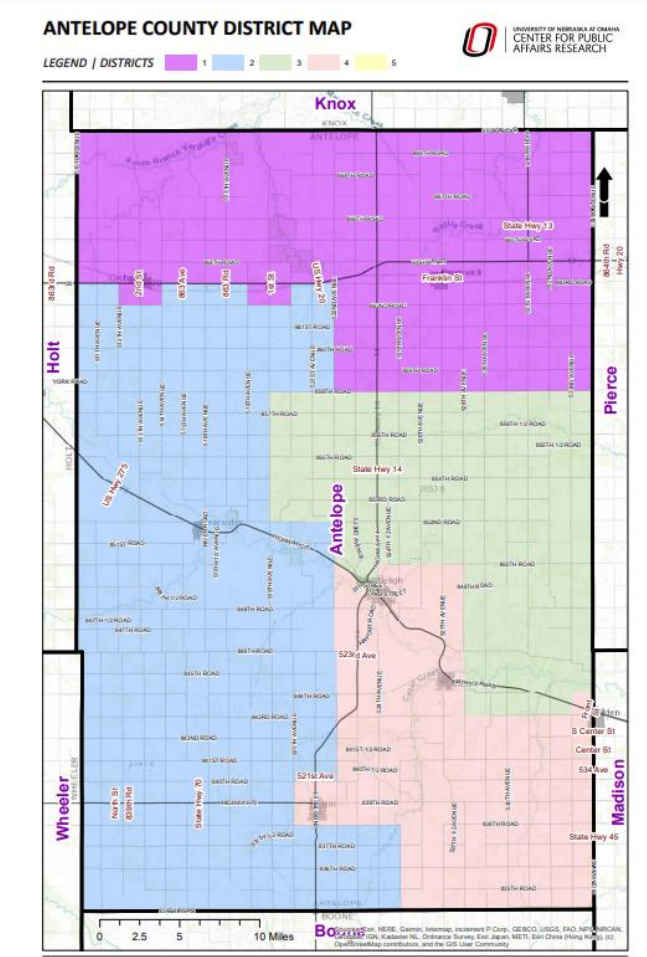
The Antelope County Board of Commissioners convened in emergency session on Thursday December 23rd, 2021 at 5:00 PM in the County Commissioner’s Meeting Room, Antelope County Courthouse Annex, Neligh, Nebraska. Meeting was called to order by Chairman Henery with the following board members responding to roll call: Jacob, Smith, Krebs, Pedersen and Henery. Chairman Henery stated the open meeting laws are posted on the east wall of the Commissioner’s Meeting Room with more copies available at the County Clerk’s Office.

Emergency meeting was held to take action on correcting and setting Commissioner Districts. Agenda for said meeting was sent to all members of the County Board of Commissioners. Meeting was available by Zoom.

Pledge of Allegiance was recited.

Agenda: Motion by Commissioner Pedersen, seconded by Commissioner Krebs to approve agenda as presented. Voting aye: Jacob, Pedersen, Smith, Krebs, and Henery. Nays none. Motion carried.

Redistricting: After more review of the districts set in the December 21st, 2021 Board Meeting there were population discrepancies and boundary line changes. After visiting with Josie, from UNO some updates and changes were recommended. The updated map had been shared with the Commissioners. Discussion today is favorable for the consistency and clearer boundary lines. Motion by Commissioner Krebs, seconded by Commissioner Jacobs to accept and replace current map and verbiage as the Commissioner Districts as set per statute. Any previously passed districts will be come null and void at this point. Voting aye: Smith, Krebs, Jacob, Pedersen and Henery. Nays none. Motion carried.



Antelope County Descriptions:

District One: Township/Range N28-W05, Township/Range N28-W06, Township/Range N28-W07, Township/Range N28-W08, Township/Range N27-W05, Township/Range N27-W06, Part of Township/Range N27-W08 [sections 1-6, 9 and 10], and Part of Township/Range N27-W07 [sections: 1-6, 9 and 10].

District Two: Part of Township/Range N27-W08 [Excluding sections 1-6, 9 and 10], and Part of Township/Range N27- W07 [Excluding sections: 1-6, 9 and 10], West half of Township/Range N26-W07, Township/Range N26- W08, Township/Range N25-W07, Township/Range N25-W08, Township/Range N24-W07, Township/Range N24-W08, Township/Range N23-W08, Township/Range N23-W07 [Excluding sections: 1, 2, 11, and 12], Part of Township/Range N23-W06 [Including sections: 16,17,18,19,20,21,28 and 29].

District Three: The East half of Township/Range N26-W07, Township/Range N26-W05, Township/Range N26-W06, Township/Range N25-W05, North 1/3 of Township/Range N25-W06, Sections 17, the area East of Hwy 275 in section 18, and an area in section 20 with a starting point of State Hwy 14 &8th Street; South to Wyle Dr/2nd Street, East to US Hwy 275 (approx. section line), North to 8th Steet (approx. section line), West returning to origin. Also included is Township/Range N25-W05.

District Four: Within of Township/Range N25-W06: The South 1/3rd sections, the area West of Hwy 275 in section 18, and Section 20 – Excluding an area with a starting point of State Hwy 14 &8th Street; South to Wyle Dr/2nd Street, East to US Hwy 275 (approx. section line), North to 8th Steet (approx. section line), West returning to origin. Also included are sections: 19,13,14,15,16,21,22,23, and 24. Also included is Township/Range N24-W06.

District Five: Township/Range N23-W07 [Only sections: 1,2,11,12,3, and 10], Township/Range N23-W-06 [Excluding sections: 17,18,19,20,29,30,31, and 32], Township/Range N23-W05, South half of Township/Range N24- W05 and section 13

No other issues to discuss.

Adjourn: Motion was made by Commissioner Jacob seconded by Commissioner Smith to **adjourn**. Voting aye: Jacob, Smith, Pedersen, Krebs and Henery. Nays none. Motion passed.
