8:49 AM Supervisor Schindler motioned to meet as a Board of Equalization. Motion was seconded by Supervisor Kerkman. Voting aye: Henery, Schindler, Bolling, Williby, Kerkman, Koinzan, and Schwager. Nays none. Motion carried. Antelope County Assessor, Kelly Mueller was in attendance.

The Antelope County Board of Supervisor's convened as a County Board of Equalization on Tuesday, August 9, 2016 at 9:00 AM in the County Supervisor's room, Antelope County Courthouse Annex, Neligh, Nebraska. Meeting called to order by Chairman Schwager with the following board members responding to roll call: Bolling, Koinzan, Schindler, Williby, Henery, Kerkman and Schwager. Nays none. Motion carried. Chairman Schwager stated that the open meeting laws are posted on the east wall of the Supervisor's room with more copies available at the County Clerk's office.

Notice of the meeting was given in advance thereof by publication in the four county newspapers, legal newspapers printed and in general circulation in Antelope County, Nebraska as shown by proof of publication filed in the County Clerk's office. Agenda for said meeting was sent to all members of the County Board of Supervisors.

The following is a list of tax roll correction presented by County Assessor, Kelly Mueller.

Keith and Berniece Schlote filed a written protest after the valuation of their property clerical error was mailed to them. By statute they have 30 days after the date of notification to file protest. The protest filed by Keith and Berniece Schlote requested the value to be lowered because, "18 Year old Modular Home that required numerous repairs due to storm damage. Property Valuation based solely on photos from internet." Per Assessor recommendations valuation was lowered to 2015 value. Building \$71,410.00, Land \$18,325.00, Total value: \$89,735.00. Motion by Supervisor Henery, seconded by Supervisor Williby to accept Assessor recommendation of lowering the value to 2015 value.
