The Antelope County Board of Supervisors convened in regular session on Tuesday, April 12, 2016 at 8:00 AM in the County Supervisor's Room, Antelope County Courthouse Annex, Neligh, Nebraska. Meeting was called to order by Chairman Schwager, with the following board members responding to roll call: Kerkman, Koinzan, Williby, Koinzan, Henery, and Schwager. Chairman Schwager stated that the open meeting laws are posted on the east wall of the Supervisors' room with more copies available at the County Clerk's Office. Supervisor Schindler appeared at 8:01 AM.

Notice of the meeting was given in advance thereof by publication in the four county newspapers, legal newspapers printed and in general circulation in Antelope County, Nebraska as shown by proof of publication filed in the County Clerk's office. Activity is trending upward so far this year. Results have been good. Turnaround time on Dependency Indemnity Compensation claims for the widows has been real good. (six weeks on most recent claim)

I attended a VA Update in Grand Island on March 30th. We heard from the VA Medical Care Center in Omaha's Director M. Don Burman. He reported on his efforts to get a new facility at the Omaha VA Medical Center. Due to the triple cost overrun of the Denver VA Hospital being built at this time, the possibility of a new hospital in Omaha was pushed out several years to an unknown time frame. So he along with partners from the private sector have been working on a plan to build an outpatient Clinic on to the existing VA Hospital. This could be accomplished in the next 3 year or so. Should be some news coming out on this soon.

Ground was broken for the new Nebraska Veterans Home in Kearney. This new facility is being built to replace the one in Grand Island. They expect to have it ready for the veterans to move in by the end of 2018. When the move is completed, the old Vet's Home in Grand Island will be turned over to the City of Grand Island for development, except for a few acres at the west end of the campus where a Veteran's Cemetery is located.

Speaking of cemeteries, the new VA National Cemetery in Omaha is under construction. An Administrator and her staff are in place. They will be taking burials later this year. It is located about two miles north of Springfield, just east of 144th Street on Schram Road. The VA purchased 200 acres at that location, and it is being developed into a National Cemetery that will serve needs for the next 100 plus years.

Since last Memorial Day, we have lost 30 of our Antelope County veterans. All veterans of WWII, Korea and Vietnam are 70 or older, so you can see that this trend will stay high for the next few years. One result of this is an increase in claims for Widow's benefits.

I still pan to retire July 1, 2017. I will formally bring this to the Board later this summer.

Voting aye: Williby, Henery, Bolling, Schindler, Kerkman, Koinzan, and Schwager. Nays none. Motion carried. The room is cleared an inspection of room was performed. Executive session 9:24 AM. Out of Executive Session at 9:33 AM.

Meeting resumed at 9:34 AM meeting resumed. Chairman Schwager stated, Closed session is complete. The matter of wages and compensation was discussed. No action was taken while in executive session. We are now returning to regular meeting.

Motion was made by Supervisor Koinzan to continue wages and mileage reimbursement as before. Motion was seconded by Supervisor Schindler. Voting aye: Williby, Henery, Bolling, Schindler, Kerkman, Koinzan, and Schwager. Nays none. Motion carried.

Zoning Report: Interim (now) Zoning Administrator, Liz Doer, gave the Zoning report. She has been in contact with Keith Marvin and has agreed to meet with the Supervisor during the May 3, 2016 meeting. He will be discussing various zoning issues and plans to attend the Public Hearing for Upstream. Liz reports she is working on various issues to make sure the application is complete for the project. She has been working with Emily from Invenergy to get information; however, it is taking time. Joe Abler, county attorney, wants to review once the report is compiled. Liz has been reviewing and compiling additional information for the Livestock Friendly County Application. The DEQ letters and reports from the county livestock operations are currently not filed with the appropriate permits. Liz requested direction as to their recommendations. The filing system used in the Zoning Office is by township and range. The plan is to update the filing system so it is more accessible and user friendly (name and date).

Dean Smith met and discussed with the supervisors regarding the Public Notice sent out by FAA regarding the 64 wind towers proposed in the Upstream Project. There are some towers reported as too tall for the airspace. Mr. Smith reported during the Zoning Public Hearing Mr. Joe McNally reported there are two (2) hands to the FAA and they do not necessarily communicate. The one hand is the "paper work" and the second is the "enforcer." The ramifications of implementation is Zoning/County is the last resort to protect the airport. — Without the county protecting the airspace, there is actually no protection. There are different classes of airspace and the 10 mile pie shape area is protected by the FAA. The other towers are too tall, but are not labeled a hazard and as Mr. Schindler reported pilots will have to adjust for the varying heights. The activity of the airport is greater than one would think. Mr. Smith has been researching and the airport is utilized by various business, and entities in the area. Dean requested the passing of LB140 be passed and implemented in order to protect the airport. He requested the supervisor "Protect the Airport."

Mr. Don Meadows met with the supervisors regarding current court expenditures. There was a weeklong hearing in Antelope County recently involving three (3) attorneys, Allen, Smith, and Abler. Allen is paid by the state. Abler is the county attorney and is paid as such. Mr. Meadows is inquiring as to how all of these expenditures are being processed, and if the supervisors are aware of the expenses coming through. Discussion of claim payment continued. All claims submitted by an entity, are signed and coded to certain accounts by the reporting office and entered into the claim register at which time a cover sheet is printed and attached. The claims are then presented to the supervisors for approval. After approval is obtained a check is generated and mailed to the billing entity. Mr. Meadows referred to the order in which Judge Johnson has requested \$7500.00 for expert witnesses to defend an individual. Antelope County does not write a blank check out. All claims have to be verified and coded before they are presented and approved for payment. Mr. Abler reported Attorney Smith has not charged the county a cent in regards to the case in question, and reported the board has the right to have the claims reviewed by an uninterested third party authority. Mr. Meadows seemed to understand and left with no further questions.

Jail Inspection will be performed by Supervisors Williby, Kerkman and Schwager after meeting.

Letter from Emily Kobylarczyk, Invenergy, discussing the liability of icing issues from wind towers was shared. No action taken.

March Antelope County Clerk of the District Court Fee Report was reviewed and put on file.

Gary Borer, Antelope County Land Owner concerned with wind towers met with the board regarding the sound study being conducted by Invenergy and bridge conditions in the Invenergy construction site area. Mr. Borer has a written complaint on file regarding the noise issues of Wind Towers. Gary reported he had suggested to the Wind Study personnel to place a noise meter close to his home. He had a few issues with them in the beginning however, things seem to be better. He mentioned he believes certain wind towers had been shut off during some of the study and wonders if they were trying to skew the study and results. Maintenance is also happening on towers, which is shutting them down from time to time. He mentions this as an informational tool for the supervisors. When he spoke to them they said that is all taken into account with the results. He also requested to leave the noise collection boxes in place an additional two (2) to four (4) weeks while all of the towers are up and running. He also questioned the safety of all of the bridges in Antelope County. After the

damage that was done to bridges in eastern Antelope County he wondered if the supervisor, and Casey, had inspected all of the bridges the heavy equipment and crane had been over. The supervisors assured him the bridges are inspected annually by the Highway Superintendent, and those bridges had been inspected. They have changed the rating on some of the bridges to accommodate. Casey Dittrich reported he is confident all of the bridges are safe.

Dave Wilcox asked the supervisors if they were keeping this in mind for any future projects including the Upstream project coming up. It was the general discussion of the Supervisors the road agreement is and will be enforced. The road agreement states all repairs will be at the expense of the project company. Future projects will have a similar road agreement in place.

10:15 AM Casey Dittrich, Antelope County Road Boss gave the following report. He has spoken with Brian, Invenergy road maintenance supervisor after board discussion to inquire whether they wanted Antelope County to maintain roads at a specified rate. Brian assured Casey they will be maintaining the roads as per the Road Agreement. The agreement states roads will be maintained in as good repair as they were previous to any construction. Brian had suggested this may be 6 to 8 weeks out before work would be complete.

- 1) in followup of last weeks report, approximately \$31,000.00 has been paid by Townships, which is great.
- 2) County road employee, Eli Jacob, had been marking/signing lots of road projects and future repairs as per discussion last week.
- 3) Forecast of Rain for the weekend will allow ample time to utilize the comp time approved last week.
- 4) Overlay 4 ¾ miles of road.
- 5) Tilden Bridge Project there is a windrow east of Oakdale.

10:26 AM Supervisor Henery discussed the Road Employee hours and changes made last week. After he thought about it this week, he wondered if it needed to be brainstormed further. He expressed employees deserve to have some overtime to help with additional expenses the employee may encounter in their everyday life, that pay boost is sometimes a reward to help them get ahead, or pay for some of the extras. He wondered if maybe the overtime and comp time could be split someway. Part-time employees could not get comp time. Some of the employees had discussed a question on holiday pay, as they are not working Fridays, how would they get paid for Arbor Day. As per recommendation from NIRMA the best way to figure this out, is to take the total number of holiday hours and divide by the number of days. For clarification, Antelope County has one (1) holiday in the months of 10 day hours: April (Arbor Day), May (Memorial Day), July (4th of July), September (Labor Day), and October (Columbus Day). Arbor Day, as it is not scheduled work by the road employees would be divided into the four (4) holidays during the effected 10 hour day. The remainder of the 10 hour time would be paid at 10 hour holidays. The rest of the holidays would remain as paid during the 8 hour day time. The supervisors again discussed the question of what was wrong with what they used to have – the 45 hour work week, as that is what Pierce County is doing. A call was placed to the Pierce County Clerk and questions were asked of her. Pierce County pays a 50 hour week, with the hour over 40 paid at time and a half. However, holidays, sick and vacation days are paid at a straight hourly wage for 10 hours – no overtime is paid unless the employee has logged 40 hours of work time. Comp time alleviates the county having to pay any additional wages as overtime, which is a complete budget buster. No changes were made.

Met with Mr. Jared Reimers with Adrian Smith's Grand Island Office regarding in regards to the mobile office and any issues the board would like to discuss. He discussed various issues including Medicaid and Medicare patients, Disaster Funds availability, Weighs and Means/Health Issues/Trade Negotiations. No action taken.
