Porter (Parcels 63800 & 63900) to set up an escrow agreement, if no response to escrow agreement to start foreclosure proceedings. Voting aye: Henery, Williby, Bolling, Schindler, Kerkman, Koinzan and Schwager. Nays none. Motion carried. County attorney is to research if county can buy property currently owned by Fred &

Candice Stines (Parcel 136800) north of county barn in Oakdale for assessed value (\$2020.00) minus delinquent taxes. Taxes would be due

prior to foreclosure. No action on other parcels.
