December 13, 2016 Antelope County Board Neligh, Nebraska

The Antelope County Board of Supervisors convened in regular extra session on Tuesday, December 13, 2016 at 8:01 AM in the County Supervisor's Room, Antelope County Courthouse Annex, Neligh, Nebraska. Meeting was called to order by Chairman Schwager, with the following board members responding to roll call: Kerkman, Schindler, Bolling, Henery, Williby and Schwager. Koinzan appeared at 8:02 AM. Chairman Schwager stated that the open meeting laws are posted on the east wall of the Supervisors' room with more copies available at the County Clerk's Office.

Gary Borer met with the supervisors regarding **noise study action** taken by the Board of Supervisors during the December 6, 2016 meeting regarding the **acoustical** studies conducted by Hankard Environmental on the Prairie Breeze II Project noise complaints. He submitted a statement to the Supervisors, of which he read to the Board. Good Morning,

I was disappointed in the decision this board reached last week concerning the wind noise reports.

The zoning regulation's state the noise level is not to exceed 50 decibels. It does not specify which metric is to be used. Mr. Rand clearly states that the noise study indicates that the noise levels are above the noise levels that Antelope County allows. You cannot change the rules after the fact. By using the metric that Hankard uses, we are violating an ordinance approved by this board. By allowing this to happen, you are putting Antelope County in a liability situation. Any damage or health issues that results from towers not in compliance becomes the responsibility of the county.

Also, it means that you are changing zoning regulations without a public hearing which may render this new decision null and void.

Almost 3 years ago I came before this board and expressed my concerns concerning the effect wind tower noise would have on my property – noise and property devaluation. I met with two of you before the meeting and the rest of you at the meeting. I was pretty much ignored. I have met with the is board several times in the last

three years and was again pretty much-ignored. Now the issue has been proven. I hope you will try to solve this issue before it comes to litigation. – But it most likely will. Another thing that bothers me is that this board should have taken more time to make that decision last week. But because Invenergy said they had to have a decision last week, this board rushed in to a very hasty decision. Why do they always get what they want? Who runs this county?

Thank you.

Supervisor Schwager thanked Gary.

The supervisors requested a copy of the "letter" be shared with the county attorney. In parting, Mr. Borer states "I think we made a mistake. I really do. You left the county a liability." No further discussion.

Mr. Don Klabenes was present to discuss the **fence across 517th** Avenue in 6-25-7. Currently, the property in question has three (3) different landowners in violation of Antelope County right of way. Mr. Klabenes has mature trees and part of a garage on the Right of Way. He is willing to remove his "possessions" in the right of way so it is "right". He believes all parties should do what is "right". This is the property Tyler Kester discussed with the Supervisors during the November 1st Meeting. It seems all parties agree to make this all right. The county surveyor will be out to look and survey the property tomorrow (12-14-2016). Mr. Klabenes may own a separate piece separate from what he believes he owns. The county owns the right of way, and is not giving up that right of way. The item was tabled until Brian McDonald can offer an opinion on the situation, later today. There is a statute regarding adverse possession; where someone who has maintained the property may have a "right" to the property. There may be a trade between ground depending a review by a surveyor or abstractor is needed to decide ownership. The road right of way will be maintained by the county. It is questionable whether there is a road there, but the right of way is still current with Antelope County.

Casey Dittrich, Road Boss continued with his report. GIS Signage Contract NIRMA references a simple sign program, and has a grant to help cover up to 50% of the cost. Eli Jacob and Casey Dittrich met with Geneie Andrews regarding the program. Current mapping is with one (1) employee and very little is documented. Federal mandates require simple sign programs. The GIS Sign Program was developed with NIRMA and current Nebraska sign statutes. The GIS is currently being used by the Assessor's Office and the development of the sign program compliments it. The program is able to provide an easy way to document county road maintenance issues. The program is relatively easy to use and provides great document for the simple sign program, culverts and asset maintenance program. Geneie quoted \$10,480.00 is the cost of the program. The program has the ability to document all gravel, overlay etc. placed on all county roads. However, Casey does not see that need at this time and would like to see signs and culverts only. And possibly developing something later to compliment the sign maintenance. Starting small with the documentation on current sign placements. With the purchase of this program, Antelope County will be able to map all sign placements/maintenance and retroflectivity. The retroflectivity reading can be done by borrowing a gun from Nebraska Department of Roads. At which time the location and sign will be documented and downloaded to the system. The initial set up will take some time. Casey is planning on working with Eli during the first part of 2017 to get the location and retroflectivity documented. The simple culvert program runs in conjunction with the simple sign program. The cost of simple sign program is \$8,480.00 and the simple culverts is \$2,000.00, for a total of \$10,480.00. During the initial introduction, because it is digitalized on their program for the Assessor's Office and because of what the state has and the bridge inspections Brian McDonald has done, every bridge in Antelope County is already on the program. In the future, our One and Six Year Plan can be on it. Motion by Henery, seconded by Williby to accept the Simple Sign and Culvert contract for \$10,480.00. Voting aye: Henery, Williby, Bolling, Koinzan, Kerkman, Schindler, and Schwager. Contracts were signed.

Bruce Ofe, **Antelope County Weed Superintendent**, met with the Supervisors regarding invasive noxious weeds including yellow flag iris the entire way across the county. It is in Holt and Madison County. They applied for and received a grant of \$10,000.00 with the NRD matching of \$5,000.00 Upper Elkhorn NRD in O'Neill has Total \$15,000.00. Because the 'Yellow Flag Iris' is not currently listed by the State as a noxious weed. It is very invasive. The plan is to hire a helicopter to spray this 'iris'; however, an approval from the landowner is needed. Mr. Ofe will be contacting as many land owners as he can this winter so they spray next spring. They have been noting various areas with other noxious weeds. This grant money has to be spent by the end of July.

Brian McDonald, Highway Superintendent met with the Board requesting they start thinking of changes to the **One and Six Year Program** that will need to be made during the 2017 year. We will probably meet in January, and have a public hearing in February.

Bid opening for Elgin Northeast, JEO Project #160023 (Schuchardt Corner). Bid opening for the project was at 10:00 AM. Brian McDonald was here for bid opening. Three (3) bids were received. A&R Construction Company \$ 282,650.17, start date 06-15-2017; Husker Engineering \$ 296,268.60, start date 06-17-2017; Myers Construction, \$ 423,781.90, start date 05-14-2017. Motion by Supervisor Bolling, seconded by Supervisor Henery to accept A & R Construction Company bid as apparent low bid, bending verification of numbers. Voting aye: Bolling, Henery, Williby, Kerkman, Koinzan, Schindler and Schwager. Nays none. Motion carried. Still negotiating ROW with Novaks.
