The Antelope County Board of Supervisor's convened as a County Board of Equalization on Tuesday, July 1, 2014 at 9:30 AM in the County Supervisor's room, Antelope County Courthouse annex, Neligh, Nebraska. Meeting called to order by Chairman Schwager with the following board members responding to roll call: Bolling, Brandt, Kerkman, Baker, Williby, Henery and Schwager. Antelope County Assessor Heather McWhorter was also present. Chairman Schwager stated that the open meeting laws are posted on the east wall of the Supervisor's room with more copies available at the County Clerk's office.

Notice of the meeting was given in advance thereof by publication in the four county newspapers, legal newspapers printed and in general circulation in Antelope County, Nebraska as shown by proof of publication filed in the County Clerk's office. Agenda for said meeting was sent to all members of the County Board of Supervisor's.

Antelope County Assessor Heather McWhorter presented two Exemption Applications for the county board's approval and/or denial. St. Theresa's Church of Clearwater – Lot 5 and the North Half of Lot 9, Block 9, Village of Clearwater, to be used exclusively for religious purposes - St. Theresa's Church of Clearwater will be removing the house located on this property and using the ground for a parking lot for the nearby church; and an application from the Orchard Amish Church – a tract of land lying wholly in the NW1/4NW1/4 of Section 4, Township 27 North, Range 8 West of the 6<sup>th</sup> P.M., Antelope County, Nebraska described as follows beginning at the Northeast corner of the NW1/4NW1/4, thence west on the section line 24' to the place of beginning thence South parallel to the east line of said NW1/4, 250', thence west parallel to the North section line 120', thence North parallel to the east line of the NW1/4NW1/4, 250' to the section line thence East 120' to the point of beginning; said property to be used for burial of church members. Exemption applications reviewed. Motion by Henery, seconded by Kerkman to approve the exemption applications submitted St. Theresa's Church of Clearwater for Lot 5 and the North Half of Lot 9, Block 9, Village of Clearwater – said lots to be used as a parking lot and the Orchard Amish Church for the 250' X 120' tract of land lying wholly in the NW1/4NW1/4 of Section 4, Township 27 North, Range 8 West of the 6<sup>th</sup> P.M., Antelope County, Nebraska – said tract to be used as a cemetery. Those voting aye: Baker, Williby, Henery, Bolling, Brandt, Kerkman and Schwager. Nays none. Motion carried.

Motion by Williby, seconded by Kerkman to adjourn as a County Board of Equalization. Those voting aye: Williby, Henery, Bolling, Brandt, Kerkman, Baker and Schwager. Nays none. Motion carried.

Meeting adjourned at 9:32 AM.
